## **Our Growth and Progress**

We estimate that there are around 500,000 deafblind children and adults in India. In 1997, an initiative was taken by Sense International, UK to support and promote services for deafblind individuals in India. Since then,

**Raj Solanki:** For Raj, being deafblind was as if the entire world could extend only as far as his finger tips could reach. However, after his association with Sense International (India), also known as Sense India, his life was filled with a new ray of hope. He gradually overcame the challenges he faced with communication and mobility. Today, he is among the first deafblind students to pass his 10<sup>th</sup> board exams with flying colours.



# Highlights of 2011-12

The project 'Developing a model of services and a sustainable infrastructure for the integration of deafblind people in India' supported for five years by the European Union has been successfully completed. This project has been a landmark in strengthening the deafblind field in India in more ways than one. The key highlights and achievements include:



400 new organisations have been sensitised on deafblindness through various programmes and visits organised by the four Regional Learning Centers (RLCs).

266 participants attended the first ever National Conference on Deafblindness held in Delhi in January, 2011.

he quality of services is quite exceptional, both in Sense India, and in the Regional Learning Centers. Needless to say, some partners needed support in management, financial and administrative areas, Sense India ensured that they were properly guided, trained, supervised and rather strictly monitored financially. All activities were meticulously planned in advance, with collaborative practices and Sense India staff have criss-crossed the country, keeping tabs, with courtesy. The relationship between partners, were assessed quietly, but often, and found to be based on mutual respect.

### **Right to Education Act:**

The Rajya Sabha and Lok sabha passed amendments to 'The Right of Children to Free and **Compulsory Education Act** 2009'. A significant number of these amendments are concerned with the education of children with disabilities. Sense India through its Director Mr Akhil Paul, was part of the consultation meeting on 1st May, 2012 to discuss issues related to the rights of children with disabilities under the Right to Education Act. As a result, the new amendments in particular talk about giving children with multiple or severe disabilities, the choice of home-based education.

### Sarva Shiksha Abhiyan

Sense India has strategically aligned with Sarva Shiksha Abhiyan (SSA) a nation-wide Government of India initiative to ensure that deafblind children are included into mainstream education. In order to ensure good quality and need-based teaching to deafblind children within an inclusive set up, a series of training programmes were jointly held with SSA missions in the states of Chattisgarh, Uttarakhand, Kerala, Assam and Sikkim. Through this partnership, over 2,000 government teachers have been trained on issues surrounding deafblindness and on appropriate teaching techniques for deafblind children in mainstream schools.



# 2. Providing Information, Support and Training

### In the year 2011-12

 $89\,$  community workers were identified and trained to provide services and support to children in remote areas. They now serve about 500 deafblind children.

 $52\ \text{teachers}$  were trained on deafblindness and appropriate teaching techniques.

3 'National Networks' promoted by Sense India saw a tremendous increase in membership. Currently, Udaan comprises of 89 adult deafblind members; Prayaas has 662 families; and Abhi-Prerna now has 389 educators as members.

### **Specialised Training Programmes**

- Advance Training on Deafblindness under the theme, 'Educational Management of Deafblind and Cerebral Palsy' was organised for 40 trained educators in Chennai in August, 2011.
- National Training on deafblindness under the theme, 'Management of Sexual issues and Parent counseling on sex education' was organised for 35 senior educators, mentors and professionals in Ahmedabad in September, 2011.
- National level training was organised for 25 project coordinators of deafblind programmes, network members and Regional Learning Centers (RLCs) information officers in Ahmedabad in September, 2011.
- A national conclave was organised for Network members under the theme of 'Empowering Deafblind through Self-Advocacy' in Ahmedabad in July, 2011. About 120 members participated in the conclave.
- An extensive training of 18 days on Multi Category disability for 300 master trainers was organised by Sarva Shiksha Abhiyan (SSA) with assistance from Sense India.The trainers came from across India.

# International Initiatives

# **Evolution in Bangladesh:**

Our partner organisation Centre for Disability in Development (CDD) has expanded its reach to 482 deafblind individuals in Bangladesh with the help of 16 local NGO partners. We have also aligned with 10 more organisations to provide need-based services to deafblind people and their families. This initiative has helped us to establish services in 15 out of 65 districts of Bangladesh where deafblind individuals and their families are continuously receiving rehabilitation support and counseling. During the year, deafblindness was integrated into the draft Disability Bill of Bangladesh as an outcome of advocacy efforts by the National Resource Center (NRC) on Deafblindness.

# **Training in Nepal:**

Sense India organised nine days intensive training on 'Deafblindness and Multiple Disabilities' at Bhaktapur, Sanothimi, Nepal for the officers of the Education Department. Mr Sachin Rizal, Sr Officer Programmes and Mr Uttam Kumar, Manager Programmes, Sense India, were the key resource persons.
