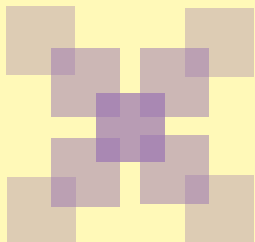

Speech-Language Pathologists Graduate Students August 17-24, 2013

A hands-on opportunity for speech-language pathologists and graduate students to enhance skills working directly with school-age youth who stutter, while under the guidance of recognized experts in the area of fluency disorders.

Training applies Basic Principle Problem Solving, a way of “clinical thinking,” focused on individual needs, positive relationships, and evidenced based practices during the therapeutic process.



Trainees participate in two days of lecture, discussion, and planning prior to camper arrival. Small and large group interactions with campers and participants occur in both structured and naturalistic contexts, under the guidance of Board Recognized Fluency Specialists, Kristin A. Chmela, June H. Campbell and Dr. Kevin A. Eldridge.
