OUR CSR PROJECT ENCOMPASS

Awareness, Education & Training in the socio-economic, health & wellness sectors. Future Projects

1. A Day-care center for children of daily wage workers in slums of Navi Mumbai, provide basic education & nourishment on a daily basis: Project Cost is Rs 26.5 lacs, incl. construction cost & operating cost for first year, for approx 150-175 children
2. Old age & Welfare Home for Women for their empowerment under "Learn & Earn Scheme"
3. Vocational Training Center for Adivasi & Class 8/10/12 drop-out children for their economic development at Shahpur/Khopoli at a cost of Rs 108 lacs
4. IT skill development program for girls/women at Navi Mumbai: Cost Rs 11.5 lacs
5. "Sadhru Balak, Sadhru Bharat" program for empowering boys & girls (below 10 years) which will take care of their long term nutritional supplements; this program administers daily & periodic doses of supplements viz., Vitamin A, B C & D along with de-worming once in 6 months as per WHO / UNESCO standards; project cost is Rs 15 lacs for one year, for about 200 children
