At all times promoting gender equality, not only as defending human rights, but also as essential for achieving the objectives of comprehensive development not only for them but also for their family and their community environment.</p> <p>We consider vital to ensure that women have a voice in all aspects of his life, as well as government institutions and civil society, so that they can participate equally in public dialogue and influence decisions that will determine their future, and the future of their families and their community. On the one hand, c on in order to accompany and enable them to defend their rights, leading areas of cooperation in society, reinse rtándolas the educational system and supporting them through collaboration with various institutions providing capacitac technical ions and entrepreneurship to generate their income autonomy. Description of beneficiaries

Beneficiaries are the direct pregnant women aged between 12 and 24 years in vulnerable situations who have lived or are endo lived a situation of violence or violation of their rights.

These women are picked up by mass distribution carried out in health centers, health centers, public schools, fairs, and other places with the highest rate of vulnerable population

They mostly follow their studies in a Center for Alternative Basic Education, not in a regular school and working to cover the costs of your child and / or family, fewer stays at home only taking the child .

In the case of expectant mothers to the extent of its possibilities may attend the scheduled sessions, when advancing pregnancy or when your child is newborn, psychologist go home to provide sessions, mainly the bond between mother and son.

When cases are detected, it is judged women, the respective diagnosis is made and proceeds to refer cases to the appropriate authorities.</p> <p>Modules work affiliation between the mother and her baby to be born and then, modules interaction between the mother and the neonate, to prevent possible cases of rejection of the woman in front of your child, for possible cases of separation or post their projects trunks life.</p> <p>Through our direct intervention of social care beneficiaries, supported by a social worker and a psychologist, it empowers women and coping strategies and defense of their rights are generated.</p>
R.2: pregnant mothers and teenagers are reintegrated into the school system and trained in production workshops to generate their own income to improve their living conditions.	Most women who are victims of exclusion or violation of rights, have few resources or capabilities that allow them to become independent from their attackers, so we believe that will be the ones most interested in reintegrated into the school system and / or participate in spaces productive workshops that enable them to generate their own income.
R. 3: Madres women leaders committed their participation in public spaces to generate support networks to influence public policy and community.	<p>It is intended to involve the community in raising awareness and awareness of this problem in favor of a development for these women and their families through joint work and advocacy in the defense of their rights.</p> <p>It seeks to create support networks for sharing expertise to local authorities and other public or private agencies working for development thus allowing to share experiences, validate the model and seek alliances for possible aftershocks.</p>

1.1. Psychological, social, legal and family care and prenatal care for mothers and their children.	<ul style="list-style-type: none"> - Is performed to the accompaniment of the family team (social work, psychology and advocacy) to detect, monitor, intervene and / or refer cases of rights violations to these pregnant teenagers and mothers. In addition, if required, the necessary procedures for the pregnant adolescent is a beneficiary of Integral Health System (SIS) and to attend prenatal checkups will be conducted on an ongoing basis. - Lso offer legal support to women and mothers who have problems with their partners or offenders in custody cases children, food or access to rights such as ion legalizac identity documents. This procedure will be carried out in coordination with the Municipal Defender of Children and Adolescents (DEMUNA) and the National Registry of Identification and Civil Status (RENIEC)
1.2 Workshops games and maternal and child stimulation targeted to be applied mothers with their children.	<ul style="list-style-type: none"> - We will promote opportunities for interaction between mother and child, both during pregnancy and during early childhood newborn. These play spaces and motor stimulation, will be directed to mothers and themselves must apply with their children, to strengthen the bond that might have been affected by the sudden change in their life projects or abandonment by their partners, parents Of his sons and daughters. - The workshops will be monitored by family team professionals, who will guide expectant mothers and

	<p>techniques of stimulation and affection, and Counseling and psychological assistance will be provided in case of cases of intolerance and / or rejection against their newborns.</p> <ul style="list-style-type: none"> - There will be an Integral Psychologist, who will hold sessions at the Cristo Rey Center and also at the pregnant teenager's home when she is unable to come to the institution. - At the beginning of the intervention with adolescent will work to strengthen the bond with your child, when this relationship is strengthened is reduced mother-child labor and incorporating based on the evaluation of the psychologist, the other social skills workshops, and The productive workshops.
1. 3. Implementation of the Program of social skills and health for mothers and children.	<ul style="list-style-type: none"> - Nutritional health program will be implemented through lectures and the development of healthy environments that promote individual, family and community well - being of both the pregnant mother as the one who already have their sons and daughters. - Self - esteem, conflict resolution, communication, participation, leadership, etc: After strengthening the mother-child bond, the social skills program where issues will be worked will be implemented. The purpose of this space is to improve the relationship with their partners, in case there is predisposition for change. - A space of care for children is proposed from 0 to 3 years of age, which we call nursery, where in addition to personal attention and entertainment and recreational spaces, offer early stimulation and nutritional support for children to record severe malnutrition or risk. Childcare hours: Monday to Friday from 8:00 a.m. to 12:00 p.m. and from 2:00 p.m. to 5:30 p.m., mainly work in the afternoon as the teenagers go to classes at this time. It is the mother's decision to leave the child in the kindergarten that will be when they work or go to school. - An children be accompanied by an assistant in care of infants, who stimulate their abilities and motor skills through different visual, auditory and movement techniques. - We also have a dining room that is open Monday through Friday, and where we can offer balanced lunches for mothers and children who need it .
1. 4. Group personal development of women IMAS Vict violence "Suma Warmi" and pregnant teenagers.	<ul style="list-style-type: none"> - The beneficiary mothers will be included in the group of mothers "Sumawarmi", which is a space offered for women who have been victims of domestic violence, can strengthen their self-esteem and develop as people to improve the living conditions of their sons and daughters . - They are monitored by a psychologist who assists them in group and individual therapies to overcome the difficult times they face. - It has also been thought of a space entirely for adolescents, through this initiative seeks to strengthen capacity improvement, self-esteem, develop skills for proper communication, control of emotions, develop the potential of teamwork, and develop Autonomy so that they find a path to personal development.

Result Activities No. 2	Brief description of each activity
2.1 Implementation of space to work with pregnant women and adolescents.	<ul style="list-style-type: none"> - It will be implemented and condition a space for conducting training and workshops aimed at pregnant women, prenatal care, psycho, emotional health, self - esteem and techniques to prepare for the arrival and baby care. In this space will always be the mother and her baby with her.
2.2. School reintegration program for teenage mothers and career	<ul style="list-style-type: none"> - Many of the pregnant teenagers that we will attend, are forced to deserter of the school system and other mothers at the time, did not get to finish their studies, by the arrival of their sons and daughters. We offer in our institution the possibility of being

counseling and training through agreements with other agencies.	<p>reinserted into the educational system, through an agreement with the Ministry of Education. These adolescents are inserted into the classroom, using a location filter and can complete their school education.</p> <ul style="list-style-type: none"> - In addition, these women are offered workshops on career guidance, business ideas and entrepreneurship. All this counting on the collaboration of other public or private organizations like the Ministry of Labor.
2 0.3. Productive workshops for mothers victims of violence.	<ul style="list-style-type: none"> - Through agreements with institutions of productive technical training, the participating mothers will be encouraged to focus on entrepreneurship so that they themselves generate income that allows them to become independent and improve their living conditions. - The recently Centro Cristo Rey has inaugurated a School of Aesthetic Education, which offer personal care workshops manicure, pedicure and others. Workshops for modules give 3 months and culminating and can start working and generate income. Here you will work with a workshop that will also match the schedules to provide the workshop according to the availability of the mothers. The groups are on average 15 mothers. It is also optional for mothers to be able to integrate the production workshop. - In this section, we will also promote in mothers, their participation in fairs and public spaces, where to show or offer their products and / or services.

3.1. Participation in areas of cooperation and networking and / or local tables.	Once accompanied and empowered women will be ready to participate in public spaces where this yt problematic issues rabajen violence prevention is addressed, trafficking and adolescent care pregnant women.
3 .2. Training and support for the strengthening of leading women's organizations and community advocates.	It will be to identify the groups of women and men who are involved with their community for their training and training in issues of rights, violence prevention, citizenship, etc. For this training will take into account the characteristics and reality of these women and men, special attention to those who have migrant and indigenous status.
3.3. Participation in awareness campaigns to the community.	Campaigns will be carried out to prevent violence, trafficking in persons, the right to life and early pregnancy. We will participate in public marches and commit the participation of the community in the intervention areas.
3. 4. Presentation and socialization of achievements to the community, authorities and media.	A call will be made to present the experience of organizing women leaders on the community, authorities and media. Also, diffusion material will be developed to present the various organized groups.

Description work

<p>Teenage mothers have weekly 1 session of 3 hours where the sessions will work in the first mother-child relationship, then art workshops, crafts workshop, weaving and training that they give state institutions (Ministry of Labor, Prosecution, Health Center, etc).</p> <p>To carry out the sessions will take into account the time of each mother, if she can come more days will not be denied. Sessions are 1 per week working with different groups, 4 per month for a year in total n estimated 40 sessions a year. The work is from Monday to Friday, but depends on the group to capture, is averaged 5 groups of 15 people</p> <p>Our goal is to work the mother and child bond, to be held in greater proportion to start working with pregnant women and mothers, based on its development will go giving the other workshops. On the subject of age range, we have other programs where we serve children, some of their mothers are under the age of 24, and we have cases in which these mothers having had their child at an early age have not established the ties of Love with them. And we want to work with them, with those who only have one child.
