Name of the organization: Warm Home Society

Title of the proposed project: Improving the Resilience and Protection of Palestinian Children

Summary of the project

The proposed action forms part of a comprehensive childhood protection strategy carried out by Warm Home Society. This action follows and aims to complete the previous "Childhood Protection project 2012-2015" funded by the EU- EIDHR/2012/298-157 and already extended through Secours Islamique France funding for the years 2016 and 2017. The experience to date, built upon lessons learnt, prepared the ground for further interventions and has been supplemented by assessments realized with the support of public actors and other non-governmental organizations (local and international NGOs, CBOs).

Through this proposal, Warm Home will then seek to improve the living conditions and strengthen the resilience of the most vulnerable girls and boys in the area of intervention and at the same time to strengthen the capacity of the community to deal with the protection issues and advocate for children. In this way the organization aims to contribute to the protection and promotion of childhood rights in the West Bank.

The proposed activities, aims to guarantee an educational and psychological support and a child friendly environment to vulnerable children living in the Kafr Ni'Ma area, for a duration of 12 months, starting from January 2018.





General context

What is the historical context? What is the social context? What is the economical context?

It is recognized among the major actors that the OPT context is affected by a protracted protection crisis with huge humanitarian consequences, exacerbated by the repetitive lack of respect of the international laws. This crisis weighs heavily on children, who comprise half of the total population. Issues related to the non-respect of basic childhood rights have been impacting upon generations of children and adolescents growing up in a society permeated by the occupation or occupation-related violence. These concerns are accentuated by the fragility of the traditional community-based child protection mechanisms. Adequate child protection responses should include psychosocial support, monitoring and documentation of the violations, legal assistance, advocacy, and interventions addressing prevention and resilience. During October 2012, the Global Child Protection Working Group issued the "Minimum Standards for Child Protection in Humanitarian Action": the document underlines the importance that these standards are respected and effectively applied in the OPT by all partners¹.

Based on these observations, we would like to address the problems of violence, negligence and abuse of children and tackle them in a broad perspective by working with multiple partners and on various levels.

Location

Where the activities will be implemented?

Kafr Ni'mah: Is a Palestinian village in Ramallah Governorate located 10.3km West of Ramallah City. Kafr Ni'ma is bordered by Deir Ibzi village and Al Janiya land to the east, Ras Karkar village and Kharbatha Bani Harith land to the North, Saffa land and Bil'in village to the West, and Deir Ibzi and Saffa village land to the South². The total population of Kafr Ni'mah in 2015 is estimated to be 4,667. ¹The main problems facing the children of Kafr Ni'ima are the absence of the family role;

which lead to neglect and failure to meet the needs of the children and as a result, many children are exposed to abuse and exploitation which was clear during the first year of the childhood protection project.

Project main goal and sub-objectives

There should be one main goal and between 3 and 6 sub-objectives (quantitative and qualitative)

Overall objective:

Contribute to the protection and promotion of childhood rights in the West Bank.

Specific Objectives:

SO1: To provide structured activities that address the immediate physical, social, emotional and cognitive needs of children

SO2: To enhance the targeted communities' & families' capacity and abilities to respond to the needs and protect their children.

SO3: To promote children participation in their own development and within their communities.





Activities

Each activity should be linked to an objective.

- **A1.1** Set up an after school care program for 40 children.
- **A1.2** Organize a summer trip for 40 children.
- **A2.1** Support 40 mothers through a monthly individual and group awareness session.
- **A2.2** Organize community awareness-raising sessions.
- **A2.3** Provide a specific 42 hours training program to 4 Psychosocial Supporters (PSS).
- **A2.4** Provide regular supervision sessions to 4 Psychosocial Supporters (PSS).
- **A3.1** A Community voluntary day (around 150 participants) in Kafr Ni'ma village is to be organized to support the villages and strengthen children and youth participation in their communities in line with standard 10 of minimum standards for child protection in humanitarian action

Expected results

What are the expected results of the activities? How will they contribute to the realisation of the objectives?

- **R1:** The children in the Kafr Ni'Ma area with particular protection needs receive educational and psychological support in a child friendly environment.
- **R2:** Strengthen the capacity of the community to deal with protection issues and advocate for children rights.
- **R3:** Children are more empowered in their interpersonal skills, knowledge about rights, duties and responsibilities.





Beneficiaries

Number of direct and indirect beneficiaries? Who are they? Who will be the targeted group(s)? Why did you choose them? Describe the selection process of the beneficiaries to be implemented

<u>Target groups</u>: 40 vulnerable children (aged from 8 to 11) alongside their parents will be targeted throughout the one year project duration. At the end of the project then, the targeted children will be on the verge of adolescence and fully equipped and supported through appropriate empowering tools. Moreover, the support of the 4 Psychosocial Supporters (PSS) trained by Warm Home and the children mothers who will benefit from the awareness sessions.

The selected children will be victims of violence, abused or negligence

, as well as children identified as vulnerable according to our criteria³, such as:

- Orphans
- Children of a single female-headed household, or where the head of the household is chronically (mental or physical) ill.
- Children with alcoholic or imprisoned parents.
- Children living in conditions of extreme poverty.
- Children exposed to conflict and war traumatic experiences.
- Abused children.
- Children suffering from labour exploitation.
- Street children.
- Children with disabilities and special needs.

The identification will be made by Warm Home, and local Child Centre. A joint need assessment will be conducted in the first phase of the proposed project in order to select the most vulnerable children already listed by the Kafr Ni'Ma center.

The PSS who will be employed in the Kafr Ni'Ma center, are already trained to identify children victims of violence through previous projects; and will be trained on more methods and

professional tools to work with children. The children themselves will also directly benefit from activities teaching them how to recognize abuse situations and ask for their rights to be respected. All the activities have been designed according to the needs expressed by the social workers, counselors, and directors of protection centers, ministries, and other INGOs during the evaluation of the previous childhood projects.

<u>Final Beneficiaries</u>: The final beneficiaries will be the population of the Kafr Ni'ma catchment, as the planned awareness and voluntary day aims to reach the inhabitants of the villages. The members of the selected children families will also benefit from individual and group awareness sessions.

Sustainability

How will the activities be financed after the funding ends? How the project will be sustainable?

For Warm Home, the added-value of the current proposal is its pluri-annual experience on childhood protection projects. The continuity of the action will definitely increase the benefits for its direct beneficiaries while seeking to tackle the root issues. All the possible measures will be undertaken in order to guarantee the pertinence and then the efficiency of the implemented activities. All the above mentioned elements will focus on creating a sustainable framework.

Visibility

What kind of action will be organised to promote France in the framework of your project? What will be the visibility of the funding of the French Consulate?

The planned activities will have positive impact on France and the French Consulate as this project will further strengthen the relationship between the consulate and the Palestinian communities involved and will enhance the reputation of Consulate as an organization that provides effective humanitarian assistance that is based on real needs and inputs of the affected communities.
