



Inspiring Teen Mothers to restore Hope and be Strong, Smart and Bold

## Project title: PROVIDE 120 TEEN MOTHERS WITH VOCATIONAL SKILLS

#### Context

The 2010 DHS reports that among children 15-19 years old who have experienced sexual violence, 41.2% experience violence first at an age between 10–14 years<sup>1</sup>. A study carried out by the Rwandan Gender Monitoring Office (GMO) in 2013 revealed continued high rates of school related GBV creating social, economic, reproductive health and educational consequences for pupils, majority girls. The study found high levels of different forms of GBV including sexual and psychological violence leading to unwanted teenage pregnancies, Sexually Transmitted Diseases (STDs), trauma, low self-esteem and school drop-out. The main perpetrators of school related GBV include teachers, sugar daddies/mummies, school workers, motorcyclists, shop attendants and saloon barbers<sup>2</sup>.

Peer pressure, sexual exploitation and resulting teenage pregnancy remain big issues in households where most of teen mothers face domestic violence. Of women aged 15-19, 6% have already had their first child<sup>3</sup>; whilst young women with no education are more than six times likely to have started child bearing at the age 19 compared with those who have secondary and higher education<sup>4</sup>.

Teen pregnancy is a health and development issue that is undermining adolescent girls' lives in Rwanda and teen mothers are subject to higher risk of dropping out of school, getting involved in unpaid exploitative work, diminished long-term wage earning, low self-esteem, social isolation and lack of safety nets.

**Overall Goal**: Provide vocational training skills considering employable skills and financial literacy to enable teen mothers become agents of change in their communities.

## **Objectives**:

- 120 teen mothers are expected to have increased skills in financial literacy for their economic participation.
- 120 teen mothers are expected to create jobs for themselves through the growth of their vocational skills

The project will support 120 teen mothers allowing them to rise out of unpaid exploitative work, diminished long-term wage earning, low self-esteem and social isolation and then enable them to become agents of change through the increase of self-esteem, employability and market access. Their empowerment will halt the cyclical teen pregnancies and domestic violence faced in households and then contribute to well-being of teen mothers and their kids and other families members.
