farmers are still not aware of any climate change issue. They are continuing their toil in business as usual way. In such condition the situation is intensifying day after other. To tackle this issue climate change adaption and mitigation is strongly recommended for sustainable agriculture.

With last 13 years of our experience in working with farmers we compellingly believe that farmers need thorough and consistent service in terms of their capacity building, new farming tactics in climate change scenario, motivation towards better organic farming, water harvesting etc. This can only be possible with establishing 'Agri-Clinic Center'. Following are the points which demands the intense need of this service center in Washim-

• One soil testing center located in remote area is serving entire Washim district that too is lacking expertise personnel's.

• Due to lack of knowledge and understanding in farmers, hundreds of government schemes and benefits can't reach up to the beneficiaries.

- Water table in the area is historically lower down, water harvesting only can help to improve the situation. That too need to convince to the farmer in effective way.
- Organic farming or zero budget farming is need of today's agriculture this needs to encourage.
- Along with technical trainings and capacity building farmer needs psychological counselling to be able to tackle the present situation.

### B. Key objectives

Our key objectives to undertake this project are-

- To help the farmers to tackle with the present situation of farming in Vidarbha
- To provide the extension and other farming services like soil testing, plant protection service, seed processing, vermin composting, etc.
- To arrange seminars, training events, campaigns on water harvesting, organic farming, government schemes, entrepreneurship development, etc.
- To create gainful self-employment opportunities to unemployed agricultural graduates, agricultural diploma holders, etc.
- To prepare expertise manpower and resources in area to tackle agriculture issues in Vidarbha
- C. Key Focus areas

Being a project location a district headquarter, we will easily reach to 5 blocks (taluka places) in our district. But at the beginning we can easily target minimum 1500 beneficiaries annually from 2,50,000 population spread in 128 villages of Washim block (taluka).

Brief Description of the project (100 words):

We have undertaken the project for 'Alpa-bhu-dharak' (Minimal Land Holders) in collaboration with Taluka Krushi Office, under which we are facilitating agriculture cultivation to the farmers on non-profit basis. Through this scheme, farmer pays for the diesel and driver charges of the tractor and cultivates their land. Hundreds of farmers are now our beneficiaries availing the benefit of this scheme doing efficient farming.

First time with the assistance from Agriculture department for 'Vasundhara Panlot' we have trained the farmer's and SHG's with water harvesting techniques, Crop and water management, duties and responsibilities of PIA. This program implemented in IWMP Cluster No. 24 and IWMP Cluster No. 2. For thorough understanding we have arranged the study tours to various places under expertise guidance. Seminars on soil testing, organic farming and horticulture were arranged.
