7. Short project summary

As at June 2015, the NEMA/IOM Displacement Tracking Matrix (DTM) reports 1,385,298 IDPs in North East States and 20,659 IDPs in Abuja. UNHCR, NEMA and other Government Agencies are working together in North East and Central to curtail the effects of insurgency on IDPs. These IDPs are at risk of Sexual Gender Base Violence, Psychosocial trauma, lack of means of livelihood, access to health and medical care, shelter, wash and education. This project will affect more than 300 IDPs in WASA IDP Settlement Abuja.

Phelyn Skill plans to empower 300 unemployed women that fled from North east and North central as a result of insurgency to WASA IDP Settlement in Abuja, by providing them with quality income generating activities, sensitize them on SGBV, also provide children with nutritional food items, offer medical support to rape victims by professionals and link beneficiaries to interest free loan to start up business.

Phelyn Skill Acquisition Center (PSAC) is a Nonprofit Organization registered in Nigeria with registration number; CAC/IT/NO. 50189, and Ministry of Budget and National Planning Commission, NPC/NGO-IC/S.679/1. Phelyn is also a member of CIVICUS ALLIANCE and Nigeria Network of NGOs (NNGO). Our Vision is to skill up Nigeria. We aim to create employment, reduce poverty and enhance economic independent among vulnerable women and Youth's through advocacy, capacity building and economic empowerment.

This project will improve the well-being and living standard of women in the WASA IDP Settlement.

The project will be implemented for a period of 3 months with total budget of \$5000.

PROJECT DESCRIPTION

The Boko Haram insurgency and counter-insurgency activities thereto widened in scope and intensity throughout 2014 and 2015 in the three North East States of Borno, Yobe and Adamawa. There have been increased security incidents, leading to masses of internally displaced persons seeking safety. While the majority of displaced persons are currently in the most affected North East states, IDPs have also moved to other States throughout the country, including the Federal Capital Territory (FCT). Further, in the North Central, fierce clashes have ensued between Fulani pastoralists and Tiv or other farmers as well as communal and religious violence in Kaduna, Plateau, Nasarawa and Zamfara, which has also contributed to large numbers of internally displaced persons. This displacement from North East and North Central conflicts led to the establishment of a number of IDP locations (including informal settlements and host communities) with the FCT. As of July 2015 FEMA has reported 20,659 IDPs in FCT originating from Borno, Yobe and Adamawa States.

Phelyn Skill will provide sensitization workshop on SGBV at WASA IDP Settlement, with participants drawn from both male and female. A TEAM of medical professionals shall be available to treat rape victims. The children will be supported with nutritional food items. Women will be supported with income generating activities training, and basic account/record keeping. They will be encouraged to train others.

The Goal of the project:

The project will impact 1200 women in WASA IDP Settlement, allowing them to rise

out of poverty, which will improve the health and well-being of their families.

Objectives of the project:

- i. To increase knowledge and confidence of 300 women in WASA IDP Settlement
- ii. To train 100 women on income generating activities.
- iii. To improve the health of 100 women in WASA IDP settlement.
- iv. To facilitate the process and securing startup interest free loans for 100 women.

Activities:

- i. Advocacy visit to key stakeholders. Phelyn Skill shall conduct advocacy visits to IDP camp leaders, NEMA, Ministry of women affairs and the Banking Management.
- ii. Sensitization and Workshop on SGBV to enlighten the IDP about the project.
- iii. Medical treatment to rape victims.
- iv. Nutritional food items for the children.
- v. Training on income generating activities
- vi. Phelyn shall facilitate linking beneficiaries to Banks for interest free loan for startups.
- vii. Monitoring and Evaluation
- viii. Mentorship support
