1. Project Title: Care & Support Home With Quality Of Health Care, Life Skill Education For Orphan Children

2. Objectives Of This Project:

The Orphan Children gathering waste papers and rags in the Orphans, and those working as cleaners in hotels and canteens, begging on railway platforms and bus stations will be gathered and rehabilitated in a Rehabilitation Home with food, shelter, medical care etc. Besides literacy will be taught to them. For the Orphan children aged above 12 years of age, Education and vocational training will be provided to them so as to enable them to become skilled workers, after the training. They will be provided training in carpentry, Nawar making, Agarbathi making, Plastic cane works, black smithy etc. In other works the Destitute children will be provided with the following facilities at the Rehabilitation Centre:

- 1. To Provide the Basic Services like Shelter, Food, Clothing.
- 2. To enable Needy Children with elementary skills to help them be self-dependent and self-reliant.
- 3. Minimum Education will be provided to the children at the Orphanage Home.
- 4. For Children of 10 Years and above they will be provided with vocational training in handicrafts and other skilled courses. Training in Carpentry, Nawar making, Agarbathi making, Plastic cane works, candle making, (wax), and black smithy etc. Trades so that they become skilled workers and earn some skilled job.
- 5. Necessary medical care will be provided to them and preventive care will be taken against attack of Diptheria, Tentanus etc.

6. Nutritious feed will be provided to the children besides sanitation and cleanliness and they will be guided to lead a suitable healthy life.

3. Project Summary:

According to UNICEF, children worldwide lose their parents in conflict, or due to poverty, disability, HIV/AIDS. Hence there is a large population of children that grow up without one or both of their parents. Children without parental care are at a high risk of abuse, exploitation and neglect. Large numbers of children end up in institutional care. Inadequate individual care of institutions can socially and emotional impair children.

In India the child parent relationship is often seen as one of obedience of a social order more so than a right of the child. Hence when a child is separated from his/her parent it is not viewed as the duty of the state to provide that child with a family environment. None the less adoption is supervised by the state, but India does not have a long term foster care or alternate care system outside of institutionalization.

UNICEF estimates that there are 25 million orphaned children in India in 2015. Another study estimates there are about 44 million destitute children and over 12 million orphan and abandoned children in India, yet there are only 5000 (0.04%) adoptions every year. The institutions for children in conflict with the law host about 40,000 children. The wide gap that exists in the knowledge of and attitude towards child adoption and intention to adopt a child between people from different socio-economic backgrounds exposes the need of the state to initiate promotion of child adoption and creating a system of non-institutional care for children above the adoption age.

7. Project Location:

30 Villages in Kurnool Rural of Kurnool District in Andhra Pradesh State and Jogulamba Gadwal district of Telangana state.

8. **DESCRIPTION (OPTIONAL)**:

STATISTIC OF ORPHAN'S IN INDIA:

According to the Latest 2015 Survey the Indian Orphan children statistics is as follows:-

- a) The total children under **0-14year** age in India is approx **34,01,19,00**.
- b) Out of that approx **2**, **32**, **46**,**000** are Orphan children which is approx **6.8**% of total Children.
- c) With that, approx **8,3,64,000** many children are maternal Orphan and **1,57, 97,000** Are paternal Orphan whereas according to the report approx **9,15,000**are Double Orphan, which means those children has no parents. Whereas according to the Survey 2005 the Indian Orphan Children statistics is as follows:-
- d) The total children Under 0-14year of age is approx 34,20,54,000
- e) Out of that approx **2,51,59,000** are Orphan Children which is approx **7.4**% of total children.
- f) Approx 96,89,000 many children are maternal Orphan and 1,65,82,000 are

paternal Orphan whereas according to the report approx 11,12,000 are Double Orphan.

9. Additional Information:

IT IS IMPORTANT to draw a picture about the personal background of the Orphan children before drawing any picture about their problems and perspectives.

In this an attempt has been made to analyze and present the personal characteristics of these children.

AGE: Age is an important characteristic of the children which determines many of their personal aspects. As such data regarding their age was collected. It was found that 43% of these children out of sample survey of 50 of them are in the age group of 12-14, followed by 20 respondents falling within the age groups of 10-12 years. However the study revealed that there a very few children who are below the age of above five years and below ten years.

SEX: An analysis of data regarding sex of children revealed that a large majority of them are male. These points to the fact that most children are predominantly male children. If it happens that there are one or two females, they will be forcibly taken away by the henchman and Orphan rewides and sold to brothels. Hence the girls among the Orphan children are rare and even nil.

RELIGION: A Majority of these children belonged to Hindus, and pertaining to lower or proper sections of the Society, while there are children belonging to Muslims and Christians also.

10. WHAT IS THE PROBLEM?

POVERTY is the major reason, which makes the majority of children vulnerable, but it should be mentioned here that this is not the only reason for trafficking. Looking at per capita expenditure on social sector by major states we can again see that Andhra Pradesh have gone

up but maximum women and girl children are trafficked from these states for brothel based prostitution.

CHILD MARRIAGE still exists in our country and so does dowry. If we see the situation closely then we see that any man who does not claim a "dowry" at the time of marriage is considered as the perfect groom and the daughter is carelessly "disposed in marriage". The girls are thus trafficked in the name of marriage. The groom may be no less than a pimp looking for a new victim. Many girls as a result are trafficked in the name of marriage to Uttar Pradesh, Bihar and other states.

SOCIAL STIGMA associated with single, divorced, unwed, widowed, sexually abused women and young girls also is a major contributing factor. The unwillingness of the society to accept them as an integral part leads to frustration, isolation and with no support system to provide them security, they fall a prey to the traffickers.

11. HOW WILL THIS PROJECT SOLVE THE PROBLEM?

By implementing this project, the Orphan Children wandering aimlessly and without proper parental affection and care will be provided Health Care & Life Skill Education & Vocational Training. They can get the social education which will help them to lead a fine life with social status. The Vocational Training will create confidence in them to avail self-reliance. The Home is started in **Kurnool of Kurnool District presently with 20 Orphan Children**. The program is aimed for a minimum period of five Years, so that the benefits of the program reach the maximum number of Orphan Children and to achieve sustainable development to a good number of Orphan Children.
