THE PROJECT

LET'S GIVE 300 FAMILIES A SAFE HOME

Managed by our re-construction Program-*With Your Own Hands*) - This program has the support of donations provided by the FEMA-VALOR program, which cover 85% of the construction materials needed. FEMA's contribution helps to acquire most of the needed inventory to rebuild the houses of all the participants who apply to our program. The organization performs two visual inspections per case to assure that the construction is made by following policies and codes requested by FEMA and/or City regulations. In only four weeks the program has helped 37 families: 12 ready for FEMA inspection, over 100 pending cases for interview and documentation and 87 more families ready to pick up or receive materials.


