# ABOUT NEW LIFE



Now in existence for over 27 years, **The New Life Charitable Trust (NLCT)** continues to strive to expand its programs and offerings to the community in fields like Elder Care, Child Care, Village community, Protection of Animals and other service areas.

NLCT is devoted to the service of the destitute community and preservation of sacred cows.

Currently, NLCT runs an unpaid home with 120 residents which includes old destitute, helpless children and workers. We also have a Ghosala with 63 cows and work towards the development of Eraiyur village community and skill development of children of the village and Panchayat union middle school.



# FOUNDERS DESK



## How NLCT started .....

We, Mr. A. A. Swamy and I were government employed couples. We always wanted to help out the needy and destitute people. We started our service at the government hospital in our own little way. During one such visit in the year 1991, we came across two helpless adults, who had just been discharged from a Government Hospital and had nowhere to go and, we wanted to house them. With not much finance but lot of good intentions, we decided to house these 2 helpless people in a small hutment in our ancestral property. This small hut with 2 grew up to 34 by the year 1997. This growth led to the registration of a Trust as "The New Life Charitable Trust" in the year 1997. Mr. A. A. Swamy took voluntary retirement from this job at TNEB and donated 5 acres of his ancestral land at Eraiyur to The New Life Charitable Trust.

Gradually, over the years, our appeals to various individuals, associations and corporate houses resulted in generous contributions enabling us to put up a full-fledged structure that now houses 80 adults, 15 children, 25 working staff and 63 cows at Goshala and also helps us serve the entire Eraiyur village.

Looking back at the 27 years of our journey with NLCT, we feel happy at the growth and improvement in the facilities for the destitute persons and the young abandoned and orphaned children and cattle. Though we continue to serve with a smile on our lips but with a tear in our eye we hope that such old age or children's homes do not grow in numbers as the residents long for their own families. This growth in number of old age homes serves as a lesson to be learnt by the younger generations to shelter their parents.

We are forced to run such shelters as there are many helpless senior citizens or children who do not have families and have nowhere to go. To quote Late Mr.P.N.Devarajan, our Board member, a veteran social worker and businessman *"It is a pity that we lack social work professionals and that social work is not considered a serious profession. The burnout rate is faster in professions with a market wage while social workers are entitled to a living wage, which more than meets their demands at the same time bringing tremendous job satisfaction. But most of the time even a living wage is not there. These people are driven by a desire to give back to society but it helps if they also possess skills."*

We at NLCT are in search of such people who can take up social work as their profession in the right sense to take our work forward in coming years.



# ORGANISATIONAL OBJECTIVES

**Objective 1: To provide care and support for the elderly and the destitute –**

**Saranagathi ( sr Citizen's home) & Danvanthri ( Nursing care Unit – 24 hrs individual and special nursing care for sick patients**

**Annapoorna – kitchen cum dining hall – with a capacity to serve 150 residents and visitors.**

**Activities:**

1. Running a home for the elderly and the destitute.
2. Reaching out to the elderly and the destitute in Eraiyur Village.
3. Performing the last rites of the elderly and the destitute.
4. Networking with other NGO's.

**Objective 2: To foster a holistic development of the children –**

**Gokulam & Mottukal & Kalaikovil ( Residence of children) & Maduravani koodam – study hall for resident and community children**

**Activities:**

1. Operating a residential care centre for the abandoned children.
2. Providing educational aid and medical support for the children in the community.
3. Networking with other NGO's.

**Objective 3: To engage in overall development of Eraiyur village and its community members –**

**New Life Medical centre / 24 x 7 x 365 Ambulance service for residents and community**

**Activities:**

Facilitating and strengthening existing community level infrastructure.

**Objective 4: To rear and care for animals within the community**

**Activities:**

Lakshmi Nivas - Goshala – protective shelter for cows housing 63 cows. We also protect cows that have outlived their period of utility.

1. Building and maintaining a Goshala in the premises for the protection of cows and calves.
2. Caring for stray animals in the community.

**Objective 5 : Other areas of service**

Programs for educational skill development of school children and youth.

To carry out the last rites of residents with dignity and also of unclaimed bodies as and when referred.

To ensure proper infrastructure facilities like road and water for the village community.

Promote paddy cultivation and tree planting programs.

Empower village women folks to start their own small / cottage industry.

To make Eraiyur Village as a Model Village.

# PROFILE OF THE RESIDENTS AND IMPACT STORIES


From 2 residents in 1991 when the genesis of the Home occurred to 34 by 1997 at the time of formalization of the home, the number of destitute senior citizens increased significantly by 2010. Today the number of senior citizens of NLCT has increased to 80. Available records indicate that about 638 elderly senior citizens have been benefitted from the services offered by NLCT since inception.

On an average, the residents living at NLCT are a little over 68 years and 1/5 of them above 80 years. NLCT has several super seniors citizens (85+) living in NLCT. A larger part of the senior citizen nearly 2/3 that is 40% is women. Except for a few, most of them were married and later widowed or separated. Some of them were issueless, some were deserted by their children and some were physical or mentally challenged or had such children and were admitted along with them.

NLCT admits people of all religion and sex. Its multi religious secular profile is evident in the fact that NLCT set up Sarva Samaya Sanidhi with idols of all religion.

In terms of health of the senior citizen residents and health status, between 64% to 67 % ie about 2/3 of the residents are active senior citizens while the rest are persons with disabilities like hearing, visual impairment, physical handicap, bed ridden and mentally challenged.

### Case Studies: Senior Active Senior Citizens

Sivakami, aged 85 years came to this home about 9 years ago with her 43 year old mentally challenged daughter. She says "After my husband passed away, and I grew older, I could not take care of her alone, despite having 3 other children. So we came to this home. I help the staff here in their routine work and sometimes help the children with their studies also. I would like to live here as long as I am alive."

Nilavathy, wife of Murugan is the first senior resident who joined New Life as early as January 1992. After the demise of her husband, a carpenter and her son, she lived with her daughter for short span, after which she was deserted by her daughter and there after joined New Life Home.

Radha hails from Kozhikode, Kerala. She joined NLCT home at the age of 42 and has been living here since 1997. Married at sixteen, she got separated from her husband after a few years. Having no children to take care of her, she lived with her elder sister Ms.Thangam for few years, and then was admitted to NLCT home by her sister.

### Impact stories: Senior Citizens with disabilities

"I came to this home in 2003, from Chennai, with my son, Ganesan, aged 56, who is physically handicapped and mentally challenged. His father was missing. We were admitted by my other son. There is no problem here. We get our food and all our needs are met on time, whatever it may be and however busy the Home may be with visitors. We have all the basic needs, clothes to wear and we have no further requirements". Nagalakshmi.

"We are natives of Madurai. My wife Seetha and I moved out of our children's home about 16 years ago as my son used to mistreat us. We were earlier at a home in Tiruchannur in Andhra Pradesh. We were not happy with the food and services. The food was too spicy and that Home did not care for our well being. We had language problem. One of our friends suggested New Life and we moved immediately. We are looked after even better than our family members. We have no worries about anything. They care for us like anything. We get lots of love and affection from Appa (Swamy) and Amma (Lalitha). We want to live here peacefully as long as we are alive". Vijayaraghavan (His wife, passed away after a serious ailment. )

K. Parameswaren is a bedridden patient, having suffered a paralytic stroke. In an accident, he had suffered multiple fractures at his backbone and was under the care of his sister. After her demise, he was admitted to NLCT by a friend when he was 67 years old.

"Sunita was suffering from psychiatric problems earlier and since her recovery, has been staying at NLCT Home with her father, who expired few years ago. The place is found to be safe. She is involved in work and other recreational activities. She also is encouraged to teach the students. She is provided positive atmosphere that made her confident to carry on her life with dignity". Sowmya, cousin of Sunita.

### Impact stories: Senior Citizens who have left the Home

"My mother Kumuda was blind, deaf and diabetic. We are all working and were not able to take care of her. We found the area conducive and serene with many other old aged persons there and hence admitted her at the home. However due to her medical condition, she was scared and was not cooperative with the staff there. She would tear off the diapers and would keep complaining over the phone. She lived there for a short span of a month or so. There were no charges for her stay, food and medicines. We paid for the attendant who used to take care of her specially and other miscellaneous expenses, like diapers. However once during our visit, we felt she was not comfortable there and that the staff was not equipped enough to take care of her, and we admitted her into another home. She passed away 6 months ago". Ravikumar, son of Kumuda.

"My aunt was admitted at the home as her sons were not able to take care of her. She was nearly a terminally ill patient, only partially mobile. She would argue and fight a lot with other inmates. We felt given her existing condition, she was well taken care of. She never indicated during her stay of 9 months that she was in need of anything like medicines etc. The co-residents would bring her food as she could not walk. She used to drag herself. Since she was not able to adjust there, she had to leave the home. Her stay was free and we used to donate whatever was possible from our end. After she left New Life, she was admitted at another home through the Police Commissioner's Office. We heard of her demise about 9 months ago". Satyamurthy, nephew of Saraswathi.

### Story of Sundari & Sakthi

Sundari came to the home as 5 days old baby. The baby was very weak and needed breast feeding badly. A worker nearby fed the baby along with her baby. Today, Sundari is in 12th standard and Sakthi is doing her degree, both of them are living with their guardian.

# MILESTONE

## Year 1991 :Big Things have small beginnings - A Story of New Life Charitable Trust

Our Founder Ms. G.Lalitha & Mr. A.A Swamy used to visit government hospitals, to help the unattended patients.

In the year 1991, there were two underprivileged, physically challenged elders discharged from hospital and didn't have anyone to take care of them. The Couple Mrs & Mr. Swamy, with no prior plan to setting up a home brought two unattended elders to Eraiyur village and provided them the basic requirements – A shed and food. The seed for the New Life was sown from then.



## Year 1992:Road to Village- A Path to Humanity

27 Years back, Eraiyur Village did not have any transportation facility. Through constant efforts with Public Welfare Department, We were able to get a good road and Public Transport (bus) Facility for Eraiyur.

## 1997 – Registration as a Trust – The New Life Charitable Trust.

New Life was formally registered on February 2, 1997 as a Trust. This was a feeling of joy that a small step led to a giant leap.




## Year 2001: New Life Medical Centre & Water Facility

Eraiyur is around 30 KM away from Tambaram, which was the nearest place then to get the medical facilities. New Life had started a medical centre, around 2300 sq.ft with an intent of offer basic medical requirements to the villagers .

### Water Supply In the village

With no good water available, the trust members worked with the Panchayat Board and VHERDS (Voluntary Health Education and Rural Development Society) who donated 5 HP Motor and brought drinking water to the village.





#### **Year 2001 – First Vehicle**

First Vehicle- A fish cart was donated to NLCT by Madras Christian College, Tambaram, and Chennai

#### **Year 2004 : Adoption of New Life Medical Centre**

Indian Medical Association (IMA) adopted the Medical Centre and started giving free treatment to around 1700 villagers and conducted regular weekly camps.



#### **Year 2005: Our First Building Sharanagathi**

Basic housing facility with thatched sheds and mud changed to a 5000 sq.ft. concrete building – Sharanagathi, after 13 long years with the borewell water and overhead tank facility.

#### **Year 2006: Ambulance, Gokulam & Sarva Samaya Sannidhi**

New Omni Van Ambulance was donated by Indian Overseas Bank. Gokulam - A Separate New Building for Boys and Male residents was constructed above medical Centre.

First borewell was dug at 450sq ft and 2Hp motor was installed at Gokulam.

Sarva Samaya Sanidhi - A Secular prayer Hall was constructed with all religious idols.



#### **Year 2007: - First Generator**

First Generator was donated to NLCT by State Bank of Hyderabad, West Tambaram branch, Chennai.

**Year 2009: - Annapoorna, Lakshmi Nivas, Kalai Kovil**

**Annapoorna** - A well equipped and hygienic kitchen cum Dinning Facility was constructed

**Lakshmi Nivas ( Gosala)** was constructed for taking care of about 54 cows and was equipped with bore well and 3 Hp motor.

**Kalai Kovil** - An vocational training Centre of 2500 sq ft intended for vocational based skills like tailoring, computer, Yoga, garland making, crafts etc was built for children of NLCT as well to accommodate children from Eraiur and surrounding villages was constructed .



**Year 2011: Vocational training Units, First Motor Vehicle, New TVS 50, Second bore well at Goshala, RO Plant, Solar Plant and Water Heater, Tata Ace.**

Two units for conducting computer Training & Stitching were started. Vocational Training classes like Computer, Yoga, Sewing , Garland making was inaugurated.

First Motor Vehicle - New TVS 50 XI was purchased from Sathya Motors, Chennai.

Second bore well at Goshala was dug 450ft with 2HP motor and later replace in 2014 with a new motor.

**RO Plant**

Installed RO Plant Purifier Machine with Board, Panels & Motor & Purified Water Storage Stainless steel Tank ( 1000 Liters) to provide pure and Hygienic drinking water to residents and visitors.

**Solar Plant and Water Heater**

With aid of a German Grant project and The Rotary Club of Chennai two Solar Power plant 1.5KWA Solar Water Heater was installed.

M/s. E.I Dupont India Pvt.Ltd installed 1 KWA solar Power plant. Tata Ace, a Mini Truck was donated to NLCT by VST motors to enable purchase and transportation of essential commodities.



**2012 - Madhuravani Koodam & Dhanvanthiri, Third bore well, construction of Toilets & Bathrooms, additional Solar panel**

**Madhuravani Koodam**, A 900 Sq.Ft hall for Meditation, yoga, Chanting mantras and study hall was constructed

**Dhanvanthiri**, A Separate Building around 5000 sq.ft with basic essential medical facilities and accommodation for the sick and others who needed special care or isolation with a sperate wing for men and women was constructed. The donation for this Building was received from NRI's and collections through music programs.

Third bore well was of 700 ft with 3 HP motor was dug at Goshala as there was ground water reduction.

Toilets & Bathrooms for Girls separately constructed at Saranagathi Building

Another Solar Panel 500Wwith Battery 150AH/12V HBL & Charge Controller 12V/24V 20A PHOCOS was installed by M/s. E.I.Dupont IndiaPvt Ltd., Chennai



## 2013 – SAIL CSR project - Toilets, Bathroom and Septic tank at Ghosala.

As part of SAIL CSR Project Toilets, Bathroom and Septic tank were constructed at Ghosala.



## 2014 – Goshala Compound wall, Cultivation, completion of all infrastructural work

To safeguard cows and calves and to prevent rain water entering into the goshala premises during rainy season a Compound Wall was built.

Cultivation of vegetables, flowers and fruits were done.

All the infrastructural, renovation, installation of fire extinguisher, installation of CCTV cameras were completed.

## 2015 – PT sargam Music Program, Social Audit, ISO certification

PT Sargam – Residence of Prime Terrace, Chennai with deep passion for music conduct a yearly musical fund raising program “PT Sargam” from the year 2015 till date.

To assess the performance and transparency of the working of the organization a social audit was conducted by CSIM, Chennai partnering with SAN INDIA, UK in October 2015.

NLCT received ISO Certification ISO-9001 in the year 2015.

## In the Year 1991

When we began our journey, we just had 2 residents to care and some community people to help around. We started the “Pidi Arsi thitam” set by “Sri Maha Periyava” where every households sets apart a handful of rice everyday which would be collected by us to feed the destitute. .

Many good hearted people who had great trust and belief in us had contributed, to mention some passionate people like Mr. S. Ravikumar, Mrs. Padma Muthukrishnan, Mr. N Nagarajan who started with us then and continue their passion and serve us till date.



**1991 –** AGS office staff, colleagues of Mrs. Lalitha have played a very vital role in building a strong foundation to NLCT. They collectively contributed to NLCT, right from the inception till date supporting in all possible ways and some have passed on the baton to their children in this yeomen service .



**1997 -** Financial discipline is the hallmark of any organization,. This is made possible by our Auditor Mr. N.R.Govindarajan from the year 1991 till date, who does honorary service till date with great dedication. Our Auditors resort to accurate accounting of our financial transactions which not only bestow credibility and integrity but ensure transparency and clarity. We stand apart as a credible NGO only because of the strict monetary discipline followed by our auditor.



**1998 – 2010** - Doctors are like God, especially to Senior citizens home like ours, Dr. Gopal Swamy- DCH– served as a camp doctor from 1998 till 2010 and later on stepped in as a trustee too. He was a true doctor who worked with passion and brought in many doctors from IMA and conducted weekly camps for our residents and the community of Eariyur. Dr. Saradha, Dr. Yosadha, Dr. Rangarajan, Dr. Ramamurthy were all associated under his leadership and continue their service till date.



**In 1998** – Mr. A.P. Kumar and Mrs. Geetha Kumar, who are both Auditors by profession visited us as a donor during a program “Dine with Divine” and were very impressed by our service, Mr.A.P.Kumar, joined NLCT as an advisory member. They guided us in all our financial discipline, ethical account practices and coordinate with our Auditors and guide us in our office accounting matters with their professional accounting acumen.



**1998 – 2005** - “Saranagathi” – A Building for senior female residents was constructed in 1999. Mrs. Uma Vijayaraghavan and Mr. Vijayaraghavan were instrumental in raising funds for this building through blood camps conducted in Dubai, UAE. Almost 50% of the funds for this building were raised by them. It literally speaks, this building was built out of blood camp. NLCT feels blessed by the gesture of the couples for this initiative which has paved way for us to house more destitute senior citizens with comfort.



**2000** –Mr. Sankaran Annaswami, was our trustee from 2000 – 2006. He was the first donor for “Go Dhanam” for Lakshmi Nivas, of NLCT. Presently he is the Senior Vice President of Standard Chartered Bank and Trustee of Freedom Trust .
