### CLEARLY STATE THE PROBLEM/S YOU OBSERVE FOR THE CHILDREN ON MOVE. WHAT IS THE CURRENT SITUATION AND HOW YOUR PURPOSED ACTIVITIES WILL BENEFIT THE CHILDREN AND THEIR FAMILIES.

DELO has conducted a rapid assessment of the current situation of children in Ghazni and Wardak and Kabul provinces. The assessment was done during August 2019 and interviewed the DoLSA departments, some IDPs families with children and some community elders and social workers in Ghazni, Kabul and Maidan Shaher. According to our rapid Assessment of the field in Ghazni, Kabul and Maidan Wardak provinces, there are 2 major problems with the children on the move or IDPs.

1. Malnutrition and lack to food for children
2. Lack of hygiene and education opportunities

Our findings shows that around 1120 children are displaced with their families in Wardak province while more than 800 children are displaced in Ghazni province due to ongoing conflict and war in different districts of the provinces. These children are deprived of basic rights and services and many of them are the only bread bearer of the families and work on daily wages as porter and labor in the markets of Ghazni, Kabul and Maidan shahar cities.

These children are not able to get enough food and nutrition to grow while many of them are facing with extreme hunger and malnutrition. Some children are also observed affected by fatigue and psychosocial

problems. Lack of access to clean water and hygiene services because serious health issues for these children. These children also don't have access to education opportunities and spaces for child friendly services.

Short coming in the daily food and lack of education and protection causes many other problems for these children such as hunger and child labor issues in these cities. The parents were of the opinion that their children need food and protection but due many problems around they cannot do anything for their children and many families send their children to go the market and earn livelihood.

#### **DESCRIBE THE PROPOSED INTERVENTION. (MAXIMUM OF 500 WORDS)**

Development in Education and Literacy Organization (DELO) is a child focused NGO which mission is to protect children in all situation from abuse, discrimination and violations and to ensure children health growth with education, nutrition and sports.

As a result of DELO's rapid assessment in the Ghazni and Maidan Shaher and Kabul provinces, the program development unit has developed this concept note and identified the objectives and key outputs of the proposed solution to the problems confronting children in these provinces.

The Project will target IDPs, and most vulnerable and children on the move and host community children have improved their food and social-psyche health as well as their self-esteem and protection.

#### **Overall objectives of the proposed intervention:**

1. To enable children get enough food and nutrition and get sufficient energy through nutrition action.
2. To provide children with education and sports opportunities through child friendly spaces in both cities.

#### **Key activities of the proposed intervention:**

1. Providing targeted children with energy biscuits and milk on daily basis
2. Establishing the 3-5 child friendly spaces with sports and learning services in both cities.
3. Conducting at least 10-15 community based education and literacy classes for the children in both locations.

#### **Outputs of the proposed intervention:**

1. Targeted children have enough food and nutrition to grow.
2. 3-5 child friendly spaces are established in both cities and serve as learning and physical activities center for the children.
3. The targeted children have access to learning and literacy through 10-15 community based education classes in different locations of Ghazni, Kabul and Maidan Shaher.
