I. DESCRIPTION OF THE ORGANISATION

ARISING OF FIRE TRAINING CENTER with the acronym of A.F.T.C is a non for profit organisation, known as a social venture devoted to help people who are victims of social injustice by contributing to their socio-Professional insertion into the society, mainly orphans, widows , autochtones and marginalized people through special programs aiming at developing their minds on literacy, NTIC, leadership skills, legal assistanship ,entrepreneurship and financial help(donations...)

II. DESCRIPTION OF THE PROJECT

Broadly speaking all over Africa and countries of the third world people coming from the low economic background are victims of several social facts and injustice due poverty , impunity,negligence of local authorities to stand efficiently for their cases.

However, the observation is bitter, among most common cases recorded one can quote :

- ✓ widows are hunted from their former husband property after the deceased from the one and forced to get married sometimes with the deceased's brother ;
- ✓ orphans are victims of a trauma, they are mistreated and abandoned by the family meeting serious difficulties to pursue both academic and professional trainings ;
- ✓ Autochtones are victims of the human exploitation, rejected into the society and lack of getting support to have access to an education of quality and taking care of their daily living responsibly.

Therefore in this regard, as an altruist, and a social entrepreneur in my community, seeing the emergency to try to give a rational response toward these pressing issues, I and my co-team have thought to implement the **project sounga population** aiming at bringing rescues toward this target audience, precisely training them and giving them necessary tools to face up those challenges.

For instance for widows they are going to be sustained by our legal assistanship and entrepreneurial program helping them to defend their rights and train them to become free lance entrepreneurs for taking care to their daily living needs and children.

For orphans they are going to receive leadership training support, school tool kits and toys during christmass parties.

For autochtones they will benefit from legal assistanship training programs, educational trainings and donations.

Sounga would also bring the rescurse of the first necessity to victims from natural calamities through donations.

III. SUSTAINABILITY OF THIS PROJECT

Sounga program would be a longlife investment program to defend the human dignity to fact that the rate of people in need increases from a year to another one.

However to make it alive, we are going to organize from time to time crowdfunding campaigns to back up the program and solicit other subventions from other international charitable agencies.

IV. MONITORING THIS PROGRAM/PROJECT

To monitor the program we are going to make polling of outcomes, deal with survey quality, evaluate appreciations of users and finally draft recommendations and final reports of activities held.

V. EXPECTED OUTCOMES OF THE PROJECT

In 5 years, more than 5000 people would be trained and helped with this project,which the main recipients would be , orphans,women, vulnerable people and some local aboriginal and women associations.

Therefore, among the individuals who would benefit from this initiative would become catalysts for community change, activists, leaders,social entrepreneurs,mentors, social actors finally representatives for this fair initiative.

VI. IMPACT OF THE PROJECT

Equipping in 2 years at least 1680 widows and orphans with the potential of becoming free lance entrepreneurs to generate their own incomes via the implementation of micro enterprises.

This would help them to take care from their daily living and contribute to reduce poverty.

Reducing the rate of injustice facts and poverty through legal assistanship and entrepreneurial education.
