# HAND-IN-HAND CHARITY PROGRAM

## Individual Cases – Dialysis Aid

In the fourth quarter of 2024, our Dialysis Aid Program supported 33 kidney failure patients from the low-income or unemployed group, compared to 41 patients within the same period in 2023. Each patient receives a dialysis fee subsidy ranging from RM360 to RM1,000 per month to ease their burden. From these 33 beneficiaries, 8 are new cases. The beneficiaries listing is as follow:

## HEW KEAT SOON

Mr. Hew, 45, father of 3, lost his job due to Kidney failure. His eldest daughter, breadwinner, struggled to support the family. In Dec 24, his brother passed away for cancer and his wife must work as transporter to pay the burial fee. GHCA extended his aid to ease his hardship.



## PATHEMANI A/P KALIAPERUMAL

Mdm. Pathemani, 61, a widowed mother of 3, has kidney failure and is frequently hospitalized. Her son works as a freelance welder to sustain their expenses. In Nov 24, her son is able to support the household expenses. Thus, she is no longer requires our support.



## LEE KIM YEW

Mr. Lee, 54, single, suffers from kidney failure and is unable to work due to partial blindness condition. He lives with his elderly mother, and his siblings provide only limited support. As he awaits reaching the age limit to withdraw his EPF savings, GHCA has extended its support until Mar 2025.



## MUHAMMAD AZLI BIN ABDULLAH

Mr. Azli, 30, single and currently bedridden due to a lower limb fracture. He lives with his mother and depends solely on his Invalidity Pension and SOCSO. As of Nov 24, his Zakat application was rejected, and his health has worsened. Thus, GHCA extended his aid until Jan 25 to support his recovery.



## BASKARAN A/L ARIVALAGAN

Mr. Baskaran, 30, an orphan suffering from Kidney failure, works part-time as a machine operator and receives SOCSO aid but struggles with dialysis fees. In Oct 24, he informed GHCA that he could manage his own expenses. Thus, he is no longer requires our support.



## WONG KIM LOONG

Mr. Wong, 49, unemployed, divorced, father of one, suffers from kidney failure and rely on SOCSO and JKM. He is facing financial difficulties in covering his dialysis treatment costs. Thus, GHCA has extended his aid until Jan 25 while he explores alternative support options.

## LIEW AH SANG

Mr. Liew, 75, widowed, suffers from cataracts, hypertension, high cholesterol, and kidney failure. He depends on his daughter, single mother working as a waitress. In Nov 24, his granddaughter secured a job and started to support the family's expenses. Hence, he is no longer requires our support.



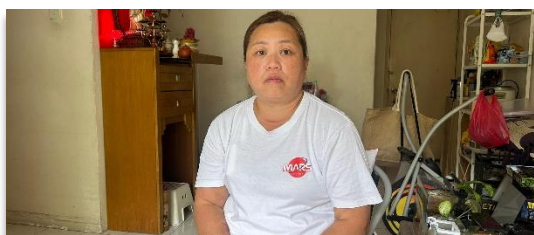
## MUHAMMAD IBNIL SHAHIR BIN MOHD ALI

Mr. Ibnil, 26, single, suffers from hypertension and kidney failure, currently lives with his mother, who works as a babysitter. In Dec 24, he was still unable to secure a job due to his health condition, as he frequently experience syncope. Therefore, GHCA extended his support until Mar 25.



## FOO YEW CHOY

Mr. Foo, 63, father of 1, and his wife both suffer from kidney failure. He currently works as a Grab driver, while his daughter is an online vendor. In Oct 24, he managed to get aid from Tzu Chi and is now able to cover his expenses. Hence, he is no longer need our support.



## NG YEE LI

Mdm Ng, 47, is married and suffers from kidney failure. She relies on SOCSO aid, her Invalidity Pension, and her husband, who works as a Site Supervisor. In Oct 24, her application dialysis NGO was successful, reducing her expenses significantly. Hence, she no longer requires our support.



## THENG CHON FAH

Mr. Theng, 61, father of 1, suffers from high blood pressure, high cholesterol, diabetes, and kidney failure while earning a living through freelance pipework. In Nov 24, he appealed for his government aid support application and awaiting response. Therefore, GHCA extended its support.



## ARUNMOZHI A/P MARIMUTHOO

Mdm. Arunmozhi, 59, a mother of 3, suffers from hypertension, diabetes, high cholesterol, and kidney failure. She relies on SOCSO aid to sustain her living. In Dec 24, as her son Grab business improved, and now able to manage her dialysis expenses. Hence, she no longer needs our support.

## LAM KONG FOON

Mr. Lam, 73, married, suffers from hypertension and kidney failure. He relies solely on his married son, a salesman, whose income is insufficient to cover his dialysis fees. In Dec 24, there was still no update from MOH for his subsidy application. Thus, GHCA extended its support.



## ARIZAL BIN KAMARUDDIN

Mr. Arizal, 31, a father of 2, suffers from hypertension and kidney. He relies solely on Zakat and his parents to support his treatment. In Dec 24, his SOCSO application was approved, and he is able to manage his dialysis expenses. Hence, he no longer needs our support.



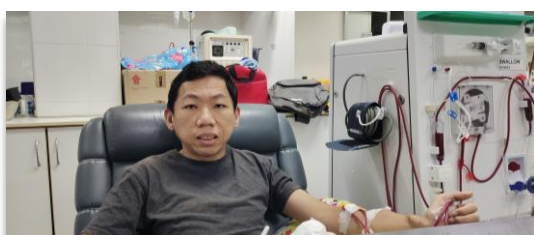
## ZAIRULNIZA BINTI AZIZUL

Mdm. Zairulniza, 44, mother of 6, suffers from high blood pressure and kidney failure. She relies solely on her husband, a personal driver, who struggles to cover her dialysis fees. In Nov 24, her Invalidity Pension application is yet to approve. Thus, GHCA extended her aid.



## RAVICHANDRAN A/L GOPAL

Mr. Ravichandran, 49, separated from his family and suffers from high blood pressure and Kidney failure. He works as a temple cleaner and struggles to cover his dialysis fees. In Nov 24, he was still waiting for his transplant procedure. Therefore, GHCA extended its support to him.



## LIEW TZER GIO

Mr. Liew, 41, suffers from kidney failure. He solely depends on his part-time job as an administrator and struggles to manage his dialysis fees. In Dec 24, he started a new job and is currently awaiting the completion of his probation period. Thus, GHCA has extended our support.



## WONG CHEW YUET

Mdm Wong, 68, suffers from high blood pressure and kidney failure. Currently, she is living with her children and relies on them for living. Last quarter, her KKM aid was approved, allowing her to settle her outstanding payments. Thus, GHCA has extended its support until its financial stabilizes.

## **GANESAN A/L ODAYAPPEN**

Mr. Ganesan, 71, suffers from high blood pressure, a history of stroke, and kidney failure. His eldest son struggles to afford his dialysis treatments, while his daughter-in-law, a housewife, has stopped working to care for him and her two children, who are still in school. Thus, GHCA extended its support to him.



## **LAI SIANG NGE**

Mr. Lai, 81, suffers from high blood pressure, high cholesterol, and kidney failure. His son, a transporter and struggles to afford both his dialysis treatments and the education expenses of his three grandchildren. Thus, GHCA extended his support till they secure other assistance.



## **SIVANILA A/P KALIMUTHOO**

Mdm. Sivanila, 52, is married, mother of 5, suffers from kidney failure. Her husband is wheelchair-bound due to an accident. She relies on SOCSO and her son's income, which is insufficient to cover their household expenses. Thus, GHCA extended her support while her son seeks a better-paying job.



## **UMMI KALSOM LIEW BINTI ABDULLAH**

Mdm. Ummi, 50, divorced, mother of 2, suffers from diabetes, kidney failure, and amputated leg, with impaired vision. She relies on her son's limited income for her living. In Nov 24, her Zakat application was approved, covering her dialysis expenses. Hence, she no longer needs our support.



## **ZAMRI BIN SENEN**

Mr. Zamri suffers from high blood pressure, diabetes, and kidney failure. He works at a factory and relies on SOCSO aid to support his family. The onset of his dialysis treatment was unexpected, placing a financial strain on him. Therefore, GHCA supports him while he works on his finances.



## **MOHD AZMAN BIN SADAR**

Mr. Azman, 40, single, suffers from high blood pressure and kidney failure. As a technician, he works to support himself and his elderly parents. Despite his income and SOCSO aid, it remains insufficient to cover all expenses. Therefore, GHCA supported him while he seeks additional assistance.

## **SARENA BINTI AHMAD**

Mdm. Sarena, 59, married, mother of 4, suffers from high blood pressure and kidney failure. Together with her husband, she works as a mosque cleaner, but their income is insufficient and relying heavily on SOCSO aid. Therefore, GHCA decided to support her while she seeks additional assistance.



## **SIVAALINGAM A/L NARANASAMY**

Mr. Sivaalingam, 52, divorced, suffers from high blood pressure, high cholesterol, Kidney failure, and eye problems. He lives alone and relies entirely on an Invalidity Pension, which is insufficient to meet his expenses. Therefore, GHCA decided to support him while he seeks for government assistance.



## **THULANDHAS A/L KRISHNAN**

Mr. Thulandhas, 66, suffers from diabetes, hypertension, and kidney failure. While his dialysis fees are partially covered by SOCSO, his son, who works in the film industry, struggles to cover the remaining costs. Therefore, GHCA decided to support him until he secured additional aid.



## **FAZLI BIN ISMAIL**

Mr. Fazli, 46, married father of 1, suffers from high blood pressure and kidney failure. His wife, the breadwinner, a cancer patient, works as a store helper. He relies on SOCSO aid, which is insufficient to meet their expenses. Therefore, GHCA supported him while he applies for Invalidity Pension.



## **LETCHUMIE A/P ARUMUGAM**

Mdm Letchumie, 53, widow, mother of 4, suffers from high blood pressure, diabetes, and kidney failure. Without any external aid, she relies entirely on her daughter, whose income is insufficient to cover her treatment. Therefore, GHCA approved her aid while she seeks additional assistance.



## **RATHAKRISHNAN A/L SAMBASIVAM**

Mr. Rathakrishnan, 69, married, mother of 4, has high blood pressure, high cholesterol, and kidney failure. Without any external aid, he relies on 2 of his children for support. However, they face challenges as they also have their own families to care for. Therefore, GHCA has approved his aid while he seeks government assistance.

## NOORLAILA BINTI ZAKARIA

Mdm Noorlaila, 40, married, suffers from high blood pressure, diabetes, and kidney failure. She depends on SOCSO aid and her husband, a security guard, who struggles to cover her dialysis treatment. Therefore, GHCA approved her aid while she seeks JKM and KKM assistance.



## VIGIYAH A/P ANDY

Mdm Vigiyah, 42, married, mother of 3, suffers from high blood pressure, diabetes, and kidney failure. Her husband, a security guard, struggles to manage her dialysis fees, and their SOCSO aid is insufficient to meet the family's needs. Therefore, GHCA has approved support for her while she applies for JKM.



## TEO BOON LENG

Mr. Teo, 51, married, father of 2, suffers from high blood pressure, diabetes, and kidney failure. Currently unemployed due to his health issues and relies on his wife, a part-time gardener. Therefore, GHCA supported his dialysis injections while he seeks additional financial assistance.
