Individual Cases – Dialysis Aid

In the first quarter of 2024, we supported 50 kidney failure patients from the low-income or unemployed group. Each patient receives a dialysis fee subsidy ranging from RM360 to RM1,000 per month to ease their burden. 19 of these patients are new cases this quarter. The beneficiaries listing is as follow:

KALAIVANI A/P PERUMAL

Mdm Kalaivani, 49, has diabetes, kidney failure, and cataract. She is supported by her lorry driver son and her son have been offered a job as a bus driver yet to start. In Feb 24, she was awaiting her divorce letter to apply for JKM disability aid, thus we extended her support until May 24.



SAROJA A/P VYAMALAI

Mdm Saroja, 78, has hypertension, heart ailment, diabetes, asthma, and kidney failure. Her daughter is still doing her part-time work as a food stall helper to support the family. We continues Saroja's dialysis aid until Apr 24, meanwhile her daughter looks for a full-time job.



CHANDRAKUMAR A/L KANAPATHY

Mr Chandra, 66, father of 3, unemployed. Struggling for his dialysis fees. In Jan 24, his MITRA application was approved to subsidise his dialysis fees. His family faced with financial constraint due to his son lost his job. Thus, GHCA extended his aid until Apr 24 while his son looks for a new job.



HEW KEAT SOON

Mr Hew, 45, father of 3, lost his job due to his kidney illness. His eldest daughter struggled to support him. In Mar 24, his Invalidity Pension is still in process and his health became worst. Thus, we extend his aid until Jun 24 to ease his burden.



THANGGACHMMA @ NAGGAMMA

Mdm Thanggachmma, 63, has kidney illness and relies on her husband, a hotel housekeeper. In Jan 24, MITRA approved her dialysis fee subsidy and she received JKM aid. Yet, her husband faces financial constraints. We extended her aid till Apr 24 due to her pending SOCSO application.



LOGESWARI A/P RAJA RATNAM

Mdm Logeswari, 46, security guard, single, has SOCSO aid, but struggled to pay her remaining dialysis fees. In Feb 24, she attempted to reapply for JKM and still waiting for response from MITRA. Thus, we extended her aid till May 24.



MOHD RADZUAN BIN ABD KADIR

Mr Radzuan, 47, divorcee, depends solely on MAIM, SOCSO aid and invalidity pension for his dialysis fees. In Feb 24, his part time car park attendant job was on hold due to rainy season. While his health was gradually improve, GHCA extended his aid till May 24 till he is able to continue his job.



KAM CHUNG FOO

Mr. Kam, 45, a father of 3, receives SOCSO aid. He drives Grab while his wife works as HR to support the family. In Feb 24, he took a month off due to an eyesight issue and is now recovering. His old house is still looking for a buyer. GHCA extended his aid for the final 3 months till May 24 while he recovers and returns to work.



LAI YEE MOI

Mdm Lai, 72, single mother of 4, is an MOH aid recipient. In Mar 24, her haemoglobin level stabilised and health significantly improved. Her son is able to support the household expenses. Thus, she no longer requires our support thereafter.



ALVIN A/L ANNANDAN

Mr Alvin, 43, father of 1, is a SOCSO aid recipient. He is unable to work due to his health condition. In Jan 24, his wife found a new job in a saree store. Thus, GHCA extended his aid for a final 3 months until Apr 24 while his wife's job stabilizes.



MATHIALAGAN A/L SANTHIRAN

Mr Mathialagan, 47, father of 1, is a SOCSO aid recipient and depends on invalidity pension and his sales marketer wife. In Jan 24, his heart had blockages and in line for an angiogram surgery. Thus, GHCA extended his aid for a final 3 months until Apr 24 while he manages his finances



SIOW POOI KEONG

Mr Siow, 70, a father of 3, suffered from kidney and heart ailments and began his dialysis treatment in May 23. Unfortunately, he passed away in Jan 24; consequently, GHCA stopped the support.



MUHAMMAD RADSYAMIR AFIQ

Mr Radsyamir, 30, single, suffers from hypertension, diabetes, and kidney illness, He stays with his parents and sister, who also a dialysis patient. In Jan 24, his Zakat application approved. GHCA extended his aid until Apr 24 while he readjusts his finances.



HAM AH KIM

Mdm Ham, 52, mother of 1, began dialysis in May 23. Her daughter, who works as an administrator, struggles with her treatment fees. As of Feb 24, there has been no update from MOH on her treatment subsidy. GHCA extended her support till May 24.



MOHAMAD DESA BIN YAHAYA

Mr Desa, 61, a recipient of SOCSO aid, started his dialysis treatment in Jan 23 and resides with his wife and son. His son, a technician, faces challenges with the dialysis expenses. In Feb 24, his Zakat application was rejected, prompting plans for an appeal. GHCA extended his aid till May 24.



PATHEMANI A/P KALIAPERUMAL

Mdm Pathemani, 61, suffers from kidney disease and relies on her son for care. She received dialysis aid subsidy from MITRA. In Feb 24, her son secured a job as an e-hailing driver. GHCA extended her support for a final 3 months till May 24, allowing time for her son's job to stabilise.



YONG CHEONG FOOK

Mr Yong, 68, single, has Down Syndrome and stays in a nursing home. He started dialysis in Apr 23. In Feb 24, his health significantly improved, and he moved to a more affordable old folks' home. His siblings were able to support him financially. Thus, he no longer requires our dialysis support.



NURUL SYAMIMI BINTI ABD AZIZ

Mdm Nurul, 35, admin clerk, mother of 2, started dialysis in Jul 23 and is a SOCSO aid recipient. In Mar 24, her freelance husband is trying hard to look for a full-time job. Thus, GHCA extended her support for a final 3 months until Jun 24 while her husband looks for a full-time job.



LEE KIM YEW

Mr Lee, 54, single, unemployed, SOCSO and JKM aid recipient, is partially blind and lives with his mother. In Mar 24, his haemoglobin level is still low. Thus, GHCA extended his support for a final 3 months until Jun 24 while his health improves.



MUHAMMAD AZLI BIN ABDULLAH

Mr Azli, 30, single, SOCSO aid recipient, stays with his mother. He depends solely on invalidity pension. In Jan 24, there was still no news from Zakat and he is trying hard to look for a job. Thus, his aid was extended until Apr 24.



IYAMPERUMAL A/L ANNAMALAI

Mr. Perumal, 74, began dialysis treatment in Jul 23. He relies solely on his JKM subsidy and daughter who works as a security guard. His daughter faces challenges in paying for his dialysis fees. As of Jan 24, there has been no response from MITRA. Thus, GHCA extended his aid until Apr 24.



BASKARAN A/L ARIVALAGAN

Mr Baskaran, 30, orphan, part-time machine operator, has kidney failure. He has SOCSO aid but struggles for his remaining dialysis fees. In Jan 24, he attempts to apply for invalidity pension. Thus, his aid was extended until Apr 24.



ROSITA BINTI MAHMUD

Mdm Rosita, 50, mother of 5, is on dialysis with MAIM subsidy. In Jan 24, her husband was unable to resume work due to chronic heart disease. Her daughter just found a full-time cleaner job. Thus, GHCA extended her support until Apr 24 while her family manage the finances.



WONG KIM LOONG

Mr Wong, 49, unemployed divorcee, father of 1, is a SOCSO aid recipient. He relies on JKM aid and struggles for his treatment fees. GHCA continues his dialysis subsidy till Apr 24 while he arranges to sell off his house for funding.



LAI LAN LIN

Mdm Lai, 75, widowed mother of 4, has kidney failure and hypertension. In Feb 24, she successfully received partial dialysis subsidy from MAZDA. Her married children still struggle to cover her dialysis fees. Thus, GHCA extended her support until May 24 while her family readjust their finances.



CHONG CHOON KEONG

Mr Chong, 51, single, has hypertension, diabetes, high cholesterol, and kidney failure. He lives with his mother and sister. In Feb 24, his MOH application was approved. Thus, GHCA extended his support until May 24 while his family manage the finances.



LIEW AH SANG

Mr Liew, 75, widower, has cataract, hypertension, high cholesterol, and kidney failure. In Feb 24, his waitress daughter divorced and struggles to support the family. Thus, GHCA extended his dialysis support until May 24 while his family readjust their finances.



SHEKAR A/L PALANIYANDY

Mr Shekar, 57, father of 2, receive SOCSO aid. His factory worker wife struggles to cover his remaining dialysis fees. In Feb 24, his invalidity pension is still processing. Thus, GHCA extended his dialysis support until May 24 while he applies for BINGKAS.



SING THIAM HOCK

Mr Sing, 65, single, stays with his 2 siblings. He has schizophrenia and rely on JKM & SOCSO aid for a living. His siblings struggle to cover his dialysis fees after a recent financial issue. GHCA extended his support him till May 24 while his family readjust their finances.



PANG TECK WA

Mdm Pang, 76, single, seamstress, stays with his brother. She and her brother struggle to cover for her dialysis fees. GHCA extended to support her till May 24 while she applies for long term aid from other NGO.



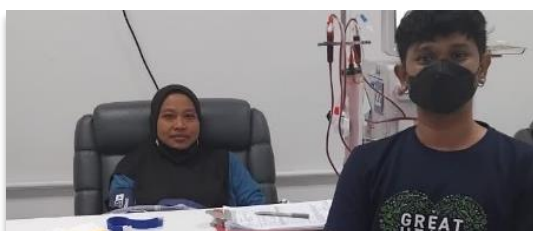
YAP FEI YING

Mdm Yap, 39, single, admin, lives with her mother and sister. She has hypertension, high cholesterol, and kidney failure. She receives SOCSO aid but struggles to cover the remaining fees. GHCA continues to support her till May 24 while she arranges to sell off her house for fundings.



PREMA A/P SUPRAMANAIM

Mdm Prema, 62, widow and lives with her lorry driver son. She is a SOCSO aid recipient, but her son still struggles to cover the remaining fees. Thus, GHCA supported her dialysis fees from Jan 24 while she attempts to apply for JKM and BINGKAS aid.



SURAYA BINTI MISKAM

Mdm Suraya, 47, mother of 3 and has hypertension, diabetes, high cholesterol, and kidney failure. She is a babysitter, and her husband works in a factory. Their income is insufficient to pay for the dialysis fees. Thus, GHCA supported her dialysis fees from Jan 24 while waiting for result from SOCSO.



MUHAMMAD IBNIL SHAHIR BIN MOHD ALI

Mr Ibnil, 26, single, living with his mother. He works in the courier services. Their struggles to cover his dialysis fees. In Mar 24, his SOCSO aid approved, but he needs additional injection fees. Thus, GHCA extended his support till Jun 24 while his health improves.



RAMANI A/P NADESON

Mdm Ramani, 57, widow, battles high blood pressure, diabetes, and kidney failure, while relying solely on derivative pension to cover her dialysis expenses. GHCA supports her dialysis fees from Jan 24, while she awaits for response on her placement for dialysis at a government hospital.



MAHYUDIN BIN MOHAMED ISA

Mr. Mahyudin, 62, resides with his wife and relies on SOCSO aid. They struggle to cover the remaining dialysis fees as they do not receive financial support from their children, who are married. Thus, GHCA supported his dialysis fees starting Jan 24 while he applies for Zakat.



VOONG CHIN EE

Mr Voong, 56, divorcee and has high blood pressure, diabetes and kidney failure. He is a SOCSO aid recipient and depend on JKM which was insufficient to pay for his remaining dialysis fees. Thus, GHCA supported his dialysis fees from Feb 24 while he looks for a suitable job.



ZULKARNAIN BIN NURUDDIN@NORDIN

Mr Zulkarnain, 55, father of 3, suffers from high blood pressure, heart ailment and kidney failure. He is a SOCSO aid recipient, but it is insufficient to pay for the remaining dialysis fees. Thus, GHCA supported his dialysis fees from Feb 24 while he applies for Zakat.



FOO YEW CHOY

Mr. Foo, 63, father of 1, both he and his wife suffer from kidney failure. He works as a Grab driver, while his daughter works as an online vendor. Their income combined is insufficient to cover household expenses. GHCA supports his dialysis fees from Feb 24 while he applies for NKF subsidy.



MOHD NOR HAKIM BIN MANAN

Mr Hakim, 50, father of 3 and a SOCSO aid recipient. He depends on invalidity pension and his factory worker wife. They struggle to cover the remaining dialysis fees. Thus, GHCA supported his dialysis fees from Feb 24 while his children look for a job after graduation from diploma.



NADRAH BINTI MOHAMAD RIDZA

Mdm Nadrah, 34, married and SOCSO aid recipient. She depends solely on her husband who works at a factory, which is insufficient to cover the remaining dialysis fees. Thus, GHCA supported her dialysis fees from Feb 24 while they readjust their finances.



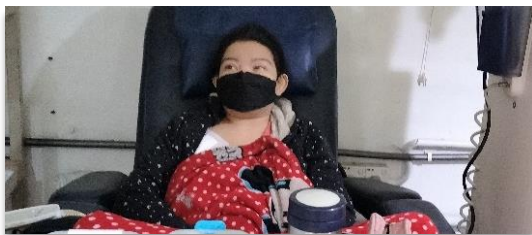
NG YEE LI

Mdm Ng, 47, married and a SOCSO aid recipient. She depends on invalidity pension and her husband who is a site supervisor, but it is insufficient to cover the remaining dialysis fees. Thus, GHCA supported her dialysis fees from Feb 24 while she attempts to apply for NGO dialysis centre.



ROHANI BINTI AWANG

Mdm Rohani, 59, single and lives alone. She is a SOCSO aid recipient and depends on JKM and Zakat. She struggles to cover the remaining dialysis fees. Thus, GHCA supported her dialysis fees from Feb 24 while waiting for result from invalidity pension application.



SITI FARIDAH BINTI MD KHAMARUDDIN

Mdm Siti Faridah, 35, mother of 1, a SOCSO aid recipient. Her husband was laid off from work recently, hence they struggled to pay for the remaining dialysis fees. Thus, GHCA supported her dialysis fees from Feb 24 while her husband looks for a new job.



LOW ENG JOO

Mr Low, 72, father of 6, suffers high blood pressure, high cholesterol, diabetes, and kidney failure. He depends solely on his married children who struggle to pay for his dialysis fees. Thus, GHCA supported his dialysis fees from Mar 24 while he attempts to apply for other government support.



THENG CHON FAH

Mr Theng, 61, father of 1 suffers from has high blood pressure, high cholesterol, diabetes and kidney failure. He does freelance pipework which is insufficient to cover his dialysis fees. Thus, GHCA supported his dialysis fees from Mar 24 while he attempts to apply for other government support.



MOHD AFFENDY BIN ABDUL HAMID

Mr Affendy, 51, father of 4 and works as an admin assistant as the sole breadwinner of the family. He struggles to pay for his dialysis fees. Thus, GHCA supported his dialysis fees from Mar 24 while he applies for SOCSO.



HO CHUN HOR

Mr Ho, 70, father of 3, depends solely on his 2 children from IT and Engineering industries, but they struggle to pay for his dialysis fees. Thus, GHCA supported his dialysis fees from Mar 24 while 1 of his children looking for a full-time job.



MUAN BOON LAI

Mr Muan, 32, divorcee and has cataract and kidney failure. He is a SOCSO aid recipient. He depends solely on his construction worker father and struggles to cover his remaining dialysis fees. Thus, GHCA supported his dialysis fees from Mar 24 while he applies for JKM.



THINAKARAN A/L ELLANGOVN

Mr Thinakaran, 25, single, suffers from high blood pressure and kidney failure. He depends solely on his mother who works as an operator and struggles to pay for his dialysis fees. Thus, GHCA supported his dialysis fees from Mar 24 while he applies for SOCSO.
