Individual Cases – Dialysis Aid

In the second quarter of 2024, our Dialysis Aid Program supported 56 kidney failure patients from the lowincome or unemployed group, compared to 29 patients within the same period in 2023. Each patient receives a dialysis fee subsidy ranging from RM360 to RM1,000 per month to ease their burden. From these 56 beneficiaries, 9 are new cases. The beneficiaries listing is as follow:

In May 24, she's still in the process of finalising her divorce before she could proceed with applying for JKM disability aid. Now, her son could manage the household expenses. Thus, she no longer requires our support thereafter.

SAROJA A/P VYAMALAI

Mdm. Saroja, 78, suffers from hypertension, heart disease, diabetes, asthma, and kidney failure. Her daughter, works part-time at a food stall, supports the family. In Apr 24, her health deteriorated, impacting her mobility. Thus, GHCA extended her aid till Jul 24 while she applies for MITRA assistance.













CHANDRAKUMAR A/L KANAPATHY

Mr. Chandra, 66, father of 3, is unemployed due to ill health and receives a MITRA subsidy for his dialysis treatment. In Apr 24, his son had found a new job, allowing his children and wife to manage the household expenses. Thus, he no longer requires our support thereafter.

HEW KEAT SOON

Mr. Hew, 45, father of 3, jobless due to kidney illness. His eldest daughter struggle to support him. In Jun 24, his Invalidity Pension application still in process, and his hemoglobin level has improved, but it hadn't reached the desired level. Thus, GHCA extended his aid till Sept 24 to ease his burden.

MOHD RADZUAN BIN ABD KADIR

Mr. Radzuan, 47, unemployed divorcee, relies on MAIM, SOCSO, and an Invalidity Pension to survive. In May 24, his hemoglobin level returned to normal, he's awaiting to start his part-time job, carpark attendant. Grateful for our 1 year of support and he no longer requires our support thereafter.

KAM CHUNG FOO

Mr. Kam, 45, a father of 3, a SOCSO aid recipient, works as a Grab driver to support his family, while his wife work as HR. In May 24, his eyesight improved, enabling him to resume his job. With his and his wife's income, they were able to self-sustain. Thus, he no longer requires our support thereafter.

ALVIN A/L ANNANDAN

Mr. Alvin, 43, father of 1, SOCSO aid recipient, is unable to work due to his health condition. In Apr 24, his wife found a full-time job as a kitchen helper, though it has yet to stabilise. Therefore, GHCA extended his aid for a final 3 months till Jul 24 to allow time for them to support the household.

MOHAMAD DESA BIN YAHAYA

Mr. Desa, 61, SOCSO aid recipient, began dialysis in Jan 23 and lives with his wife and son. In May 24, his other children, who live separately and have their own families, were able to support him after managing their finances. Thus, GHCA stopped its support since May 24.













PATHEMANI A/P KALIAPERUMAL

Mdm. Pathemani, 61, suffers from kidney disease and cared by her son. She receives a MITRA dialysis aid. In May 24, she was hospitalised due to bacterial infection, which resulted in add-on burden. Her son's job as an e-hailing driver remained unstable. Therefore, GHCA extended her support till Aug 24.

LEE KIM YEW

Mr. Lee, 54, is single, unemployed, and partially blind. He receives SOCSO and JKM aid and lives with his mother. In Jun 24, his hemoglobin level remains low, requiring injections he can't afford. He plans to withdraw his EPF funds at age 55 to support himself. Thus, GHCA extended its support for till Dec 24.

IYAMPERUMAL A/L ANNAMALAI

Mr. Perumal, 74, began dialysis in Jul 23. He solely depends on his daughter, who is a security guard, and JKM aid. In Apr 24, he received a dialysis aid subsidy from Yayasan Kebajikan Negara and Tzu Chi, his family is able to cover their household expenses. Thus, GHCA stopped its support since Apr 24.

MUHAMMAD AZLI BIN ABDULLAH

Mr. Azli, 30, single, SOCSO aid recipient, and lives with his mother and relies solely on Invalidity Pension. In Apr 24, his Zakat application remain pending, and he is still job hunting. Thus, GHCA extended his aid till Jul 24, in the hope of receiving good news from Zakat soon.

ROSITA BINTI MAHMUD

Mdm. Rosita, 50, a mother of 5, is on a MAIM subsidy. Her husband can't work due to chronic heart disease, and they rely on their daughter, a cleaner. In Apr 24, her health worsened, requiring a single-use dialyzer, adding financial strain. Thus, GHCA extended her support until Aug 24.

WONG KIM LOONG

Mr. Wong, 49, unemployed divorcee and father of 1, receives SOCSO and JKM aid but struggles to cover his treatment fees. In Apr 24, his house remained unsold, and he owed a large sum to the dialysis center. Thus, GHCA extended his subsidy till Oct 24, while he applies for Tzu Chi aid.













CHONG CHOON KEONG

Mr. Chong, 51, single, suffers hypertension, diabetes, high cholesterol, and kidney failure. He receives an MOH subsidy for dialysis and lives with his mother and sister. In May 24, his family managed their finances and able to self-sufficient. Thus, he no longer requires GHCA support thereafter.

SHEKAR A/L PALANIYANDY

Mr. Shekar, 57, a father of 2, is a SOCSO aid recipient. In May 24, his Invalidity Pension application was rejected. However, with an increase in his wife's income, they were able to manage household expenses independently. Thus, GHCA stopped its support after May 24.

PANG TECK WA

Mdm. Pang, 76, single, and a seamstress, she's living with her brother. In May 24, she expressed gratitude for our support and mentioned that she could manage financially with her savings and help from relatives. Thus, she no longer requires our support thereafter.

YAP FEI YING

Mdm. Yap, 39, single, work as admin, living with her mother and sister. She suffers hypertension, high cholesterol, and kidney failure and is a SOCSO aid recipient. In May 24, she was able to support herself after readjusting her finances. Therefore, GHCA stopped its support after May 24.

LAI LAN LIN

Mdm. Lai, 75, single mother of 4, suffers kidney failure and hypertension, receives a dialysis subsidy from MAZDA. In May 24, one child faced financial issues due to unstable income, and her married children have their own commitments. Thus, GHCA extended her support till Aug 24.

LIEW AH SANG

Mr. Liew, 75, widower suffers cataracts, hypertension, high cholesterol, and kidney failure, relies on his daughter, who is a single mother working as a waitress. In May 24, his health worsened, led to regular hospital admissions. Thus, GHCA extended his aid till Aug 24 to ease his family's burden.













SING THIAM HOCK

Mr. Sing, 65, single, lives with his 2 siblings. He suffers schizophrenia and is a SOCSO aid recipient, relying on his siblings' JKM aid. In May 24, he applied for JKM aid via another NGO to lessen his family's burden. Thus, GHCA extended his support till Aug 24.

RAMANI A/P NADESON

Mdm. Ramani, 57, widow who lives alone, suffers high blood pressure, diabetes, and kidney failure. She relies solely on a Derivative Pension to survive. In Apr 24, she secured a spot for dialysis treatment at a government hospital with minimal fees. Thus, she no longer requires our support thereafter.

NURUL SYAMIMI BINTI ABD AZIZ

Mdm. Nurul, 35, an admin clerk and mother of 2, began dialysis in Jul 23 and is a SOCSO aid recipient. In Jun 24, her husband secured a full-time job as a foreman at Perodua Service Centre, earning enough to support the family. Thus, she no longer requires our support thereafter.

PREMA A/P SUPRAMANAIM

Mdm. Prema, 62, widow, SOCSO aid recipient. She's residing with her lorry driver son. In Jun 24, she thanked for GHCA's support, and her children is currently able to support her after readjusting their finances. Thus, she no longer requires our support thereafter.

MAHYUDIN BIN MOHAMED ISA

Mr. Mahyudin, 62, residing with his wife and is a SOCSO aid recipient. In Jun 24, he mentioned that his married children were able to support him after readjusting their finances. Thus, he no longer requires our support thereafter.

MUHAMMAD IBNIL SHAHIR BIN MOHD ALI

Mr. Ibnil, 26, single, suffers hypertension and kidney failure and lives with his mother, who is a babysitter. In Jun 24, he was laid off from his courier services job due to his illness. Therefore, GHCA extended his support till Sept 24 while he looks for a new job.













THANGGACHMMA @ NAGGAMMA

Mdm. Thanggachmma, 63, suffers kidney illness and relies solely on her husband, who works as a hotel housekeeper. She receives MITRA aid JKM aid for dialysis treatment. In Apr 24, her invalidity pension was approved. Thus, she no longer requires our support thereafter.

MUHAMMAD RADSYAMIR AFIQ

Mr. Radsyamir, 30, single, suffers hypertension, diabetes, and kidney disease, lives with his parents and sister, who is also a dialysis patient. He receives a Zakat subsidy for dialysis. Currently, his family could manage expenses independently. Thus, he no longer requires our support thereafter.

VOONG CHIN EE

Mr. Voong, 56, a divorcee with high blood pressure, diabetes, and kidney disease, relies on SOCSO and JKM aid, which is insufficient for his dialysis treatment fees. In Apr 24, he started to sell bread part-time, without a fixed salary and was seeking a stable job. GHCA extended his support till Jul 24.

ZULKARNAIN BIN NURUDDIN @ NORDIN

Mr. Zulkarnain, 55, father of 3, suffers high blood pressure, a heart ailment, and kidney failure. He is a SOCSO aid recipient. In Apr 24, his health worsened, and his Zakat aid application was rejected. Therefore, GHCA extended his support till July 24 while he recuperates.

FOO YEW CHOY

Mr. Foo, 63, a father of 1, he and his wife suffers kidney failure. He works as a Grab driver, and his daughter is an online retailer. In Apr 24, they were struggling financially and applied for NKF and Tzu Chi aid, which is still pending. Thus, GHCA extended its support till July 24.

NADRAH BINTI MOHAMAD RIDZA

Mdm Nadrah, 34, married, suffers hypertension, diabetes, and kidney failure. She is a SOCSO aid recipient. She depends solely on her factory worker husband. In Apr 24, they still struggled financially and attempts to apply SUK aid. Thus, GHCA extended our support until Jul 24.













NG YEE LI

Mdm. Ng, 47, married, a SOCSO aid recipient who depends on her Invalidity Pension and her husband, a site supervisor. In Apr 24, she still couldn't find a slot at an NGO dialysis center. Therefore, GHCA extended her support till Jul 24 while she continues to seek other NGO dialysis centers.

ROHANI BINTI AWANG

Mdm. Rohani, 59, single and lives alone. She is a SOCSO aid recipient and relies solely on JKM and Zakat aid for her living. In Apr 24, she was still waiting for the results of her Invalidity Pension application. Thus, GHCA extended its support until Jul 24.

SITI FARIDAH BINTI MD KHAMARUDDIN

Mdm. Siti Faridah, 35, mother of one and a SOCSO aid recipient Her husband was laid off and still searching for a new job. In Apr 24, she applied for Tzu Chi support and still pending on response. Thus, GHCA extended her support for 3 months till Jul 24, while her husband secures a job.

HO CHUN HOR

Mr. Ho, 70, a father of 3, relies on his two children working in IT and engineering, who struggle with his dialysis fees. Currently, his children able to manage the household expenses after readjusting their finances. Thus, he no longer requires our support thereafter.

MUAN BOON LAI

Mr. Muan, 32, divorcee, suffers from cataract and kidney failure. Currently he is relying on SOCSO aid and his construction worker father for living. Unfortunately, Mr. Muan passed away in Jun 24. Thus, GHCA stopped its support.

THINAKARAN A/L ELLANGOVN

Mr. Thinakaran, 25, single, suffers from high blood pressure and kidney failure. Currently he is depending solely on his mother, who works as an operator. In May 24, his SOCSO aid application was approved. Thus, he no longer requires our support thereafter.













LOW ENG JOO

Mr. Low, 72, father of 6, suffers high blood pressure, high cholesterol, diabetes, and kidney failure. He relies solely on his children. In May 24, he applied for MOH and SUK subsidy and pending on approval. Thus, GHCA extended its support till August 24, while waiting for updates from MOH and SUK.

THENG CHON FAH

Mr. Theng, 61, father of 1, suffers high blood pressure, high cholesterol, diabetes, and kidney failure, does part-time pipework for living, which is insufficient to cover his dialysis fees. He is still compiling documents to apply for government support. Thus, GHCA extended his support.

SURAYA BINTI MISKAM

Mdm. Suraya, 47, mother of 3 with hypertension, diabetes, high cholesterol, and kidney failure. She works as a babysitter while her husband works in a factory. In Mar 24, her SOCSO aid was approved for dialysis treatment. Thus, GHCA provided final dialysis support up to June 24.

SEELAN A/L NAVANAYAGAM

Mr. Seelan, 36, single, suffers high blood pressure, diabetes, and kidney failure, has impaired eyesight. He relies on his family for support. In Jun 24, Tzu Chi subsidised his dialysis treatment, yet still struggled with the extra injection fee. Thus, GHCA extended its aid till Sept 24 while he applies for SOCSO.

ARUNMOZHI A/P MARIMUTHOO

Mdm. Arunmozhi, 59, mother of 3 with hypertension, diabetes, high cholesterol, and kidney failure. She relies on SOCSO aid and her son. Recently, her son was laid off and started working as a Grab driver. Therefore, GHCA extended her dialysis fees till Sept 24 while her son's job stabilise.

LAM KONG FOON

Mr. Lam, 73, married, suffers hypertension, and kidney failure. He relies solely on his son, a salesman, whose income is insufficient to cover his dialysis fees. In Jun 24, Mr. Lam was still struggling financially and, in the midst, to apply for MOH aid. Thus, GHCA extended its support till Sept24.













WONG KOK WAI

Mr. Wong, 52, father of 2, suffers with hypertension and kidney failure. His wife, the breadwinner of the family, works at a noodle stall, but her income is insufficient to cover his dialysis fees. Thus, GHCA supports his dialysis fees from Apr 24 to ease his family's burden.

HASZAMAN BIN HASSAN

Mr. Haszaman, 52, father of 3, has hypertension, diabetes, and kidney failure, and a SOCSO aid recipient. In Mar 24, due to worsening health, his medical cost increased, and his wife who works in sales could no longer afford. Thus, GHCA supported his dialysis treatment, to ease his burden.

MARIAM BINTI ABU BAKAR

Mdm. Mariam, 74, mother of 1, suffers with hypertension, diabetes, and kidney failure. She's retired with a daughter who can't afford to support her. During MCO, her Zakat aid was discontinued without reason. Thus, GHCA covered her dialysis fees from Apr 24 while she reapplies for Zakat.

ARIZAL BIN KAMARUDDIN

Mr. Arizal, 31, father of 2, suffers hypertension and kidney failure. He is unable to work, he relies on his parents, whose salary is insufficient for the fees. In Jun 24, despite SOCSO aid approval, he still struggled with the remaining fees. Thus, GHCA extended its aid while he applies for Zakat.

MATHIALAGAN A/L SANTHIRAN

Mr. Mathialagan, 47, father of 1, relies on SOCSO aid, Invalidity Pension and his sales-marketing wife. In Apr 24, his son graduated from secondary school and plans to continue his tertiary studies. Thus, GHCA extended its aid for up to Jul 24 while he manages his finances.

BASKARAN A/L ARIVALAGAN

Mr. Baskaran, 30, an orphan suffering from kidney failure, works part-time as a machine operator and receives SOCSO aid but struggles with his remaining dialysis fees. In Apr 24, he applied for an Invalidity Pension but has not received any news. Thus, GHCA extended his aid until Jul 24.













MOHD NOR HAKIM BIN MANAN

Mr. Hakim, 50, father of 3, receives SOCSO aid and depends on an Invalidity Pension and his factory worker wife. In Apr 24, his daughter secured a factory job. Thus, GHCA extended his aid up to Jul 24 while his daughter's job stabilises and helps cover household expenses.

ZAIRULNIZA BINTI AZIZUL

Mdm Zairulniza, 44, mother of 6, suffers diabetes, high blood pressure, and kidney failure. She depends on her husband who works as a personal driver and struggles to cover her dialysis treatment. Thus, GHCA supported her dialysis fees while she applies for SOCSO.

RAVICHANDRAN A/L GOPAL

Mr. Ravichandran, 49, separated from his family, suffers with high blood pressure and kidney failure. He works as a temple cleaner and struggles with his dialysis fees. Thus, GHCA supported his dialysis costs while he applies for SUK aid.

LOGESWARI A/P RAJA RATNAM

Mdm Logeswari, 46, single, working as a security guard and receives SOCSO aid but struggles to pay her dialysis fees. In May 24, her JKM and MITRA applications were rejected. Thus, GHCA extended her aid, while waiting to hear from NGO dialysis center.

HAM AH KIM

Mdm Ham, 52, single mother of 1, suffers with kidney failure. Her daughter, working as an administrator, struggles to cover the fees. In Apr 24, Mdm Ham's health worsened, and she reapplied for MOH assistance but pending on response. Thus, GHCA extended her aid until Aug 24.

MOHD AFFENDY BIN ABDUL HAMID

Mr. Affendy, 51, a father of 4, works as an admin assistant and is the breadwinner of the family. In May 24, his SOCSO aid was approved, but he still struggled to pay the remaining fees. Thus, GHCA extended his aid till Aug 24 while he applies for SUK assistance.
