PLAYGROUND IN LYTTON FIRST NATION COMMUNITY

MEMORANDUM OF AGREEMENT BETWEEN LYTTON FIRST NATION BAND AND THE POWER OF PLAY

I. Parties

The purpose of this Memorandum of Understanding ("MOU") is to establish a relationship between The Power of Play ("TPOP") and Lytton First Nation band (LFN.band).

II. Vision

To build a playground which is going to facilitate and provide space to play for the children in West bank, Lytton and surrounding communities.

III. Responsibilities of The Power of Play

TPOP team will collaborate with LFN.band in the following items to complete this project successfully.

• Playground Design

TPOP team will provide the design and layout for the playground.

• Repurposed play equipment

TPOP is working with school district 23 and contractors to repurpose the play equipment and install them for this playground.

• Other play equipment

TPOP will design, manufacture and install other play equipment depending on how many pieces they get to reuse from SD23

Funding

TPOP will fund the repair and repurposing play equipment that are safe to be reused from SD23. Additionally TPOP will fund the other material and fabrication required for additional equipment. TPOP will also raise funds to support the wages for labour, skill workers, and contractors to complete this playground.

Lastly TPOP will fund the transport of the elements to the location and installation cost.

• On site Project Manager

A skilled representative from TPOP will be on site once the materials are purchased and transported to the location.

• Providing maintenance manual

TPOP will create and submit a maintenance manual for the playground to LFN.band to maintain and repair the playground.

IV. Responsibilities of LFN. band

LFN. band will provide on site and local support to complete the project successfully.

Collaboration

15% of the total cost of the playground will be provided by LFN.band in the form of funding or volunteering.

LFN.band will support the project by providing required documents, photos, and videos for the fundraising, grants, and other applications.

• Effective communication

LFN. band representatives will be constantly in communication with TPOP team in every step of the project. As much as possible these communications will be supported with pictures and videos.

Safety

Safety and security of the play equipment after the build is fully responsibility of the LFN. band.

Maintenance

LFN.band will do its research and due diligence, besides following the steps and safety measures advised by TPOP to maintain and keep the playground safe for the children.

A representative from the band will perform routine inspection and maintenance on the playground.

Future collaboration

LFN.band will provide quarterly reports about the condition of the playground and the impact the playground may have on children's wellness and happiness.

BOTH PARTIES HEREBY enter into this MOU to successfully complete the build of a playground in Lytton west bank to support every child's right to learn and develop through the power of play.
