PSA's Field Agent Claude Bizimana called Lofombo Ngolu on WhatsApp.

He said that his community is sick, mostly from starvation. The people are not allowed to fish. There is no longer a place for livestock or gardens. Sanitation in their encampment is bad, and diarrhea is a serious health problem. The young children have tapeworms and suffer from severe malnutrition.

The Idjwi Island Batwa community had homes they had lived in for generations. They were getting education for their children and had food before being displaced from both work and home. They have the skills needed to live in a fishing village. We wonder, can they be moved to another place in the DRC and left to rebuild their lives?

This is a question with a hard answer as much of the DRC is struggling with outbreaks of war over its minerals.

The Congolese Army is accusing Rwanda of supporting the M23 rebels.

It is not a good time for a Rwandan to go to the Democratic Republic of the Congo.

PSA is dedicated to empowering Cyaruzinge villagers to lift themselves from poverty. A lot has been accomplished — there is a lot more work to do. PSA often includes the non-Batwa people living around Cyaruzinge village, the Batwa remaining in old Bwiza, and the Batwa of Masoro in the ongoing efforts to improve the lives of historically marginalized people.

While the villagers of Cyaruzinge, Bwiza and Masoro share what they have learned with other Batwa communities, there is not much the Rwandan Batwa or PSA can do in the Congo...yet.
