These shall be through providing shelter, Providing all basic needs as like Food, uniforms, Medication, Education, Entertainment, practical skills, promotion of hygiene and sanitation in basic primary health care and sport promotion.

Especially **Orphans & Disadvantage** needs protection, Proper guide, Proper shelter, Proper education and Health in their daily growth & Childhood living. **Food & Cloths are major issue for a child in moving into education...**

This Society is established to carry on all the activities of Children who are unable & fallen in their daily growth due to food crisis, family crisis, political crisis, social & economic Crisis...

Education helps in the complete growth of an individual's personality, whereas instruction merely trains an individual or a group in the efficient performance of some task. A human being may be a great general, an efficient carpenter or a good teacher, or a lawyer, or a mechanic or a pathologist, or a renowned doctor, or a pharmacist, or a Engineer or a chartered accountant, but still remain a semi-educated, ill- mannered, immoral, unrighteous or unjust person.

Similarly, someone may be a very fine painter, a good poet; or possess a love of beauty which is highly delicate and sensitive, but may, at the same time, be cruel or brutal, or an untruthful, unsocial individual, who deliberately ignores their duty towards neighbors or even spouse and children. We can say that people who have specialized in certain educational fields are well-instructed individuals, but we cannot necessarily regard them as truly educated. On the other hand, someone who knows and performs her duty towards self, family, neighbors and humanity, and at the same time has acquired a basic knowledge about how to earn a livelihood honestly and live a decent life, should be called an educated person. Such a person may not have specialized in a particular field of knowledge, but lack of expertise does not automatically prevent him or her from being recognized as an excellent human being. Good people are not necessarily complete people. In fact, no- one around us can be regarded as complete, because there is no end to the growth of human personality. A wide knowledge of many subjects helps in the growth of personality provided that we know how to adjust our knowledge to our behaviour, and how knowledge and action are to be integrated into a broad, total framework of life. The outlook of an educated person is not static, but is modified and mellowed as he or she applies principles to practice and acquires an outlook enriched by experience

While the objective of the is to provide basic knowledge and life skills for all school age children, primary education provision is still characterized by under - achievement which affects Children and most of the children in rural areas. The interventions suggested in the Master Plan are aimed at enhancing quality of Food, Education, Entertainment, Uniforms and Health & Hygiene which have to be upgraded.

Vulnerable needs to be highly protected, able to get all their basic needs and will provide own their future aim so that they may self reliant in their future survive.



PROJECT AREA BACKGROUND INFORMATION:

INTRODUCTION:

There's a child, born to parents who have been very poor for generations, not allowed to educate themselves or their children, ostracised from main society for centuries.

There's another child, born to some parents, but left with none, thrown in a dumpster, or

left in a park, to die or to survive on its own, no idea where to get food from, or even how to get food, now where to go, and no one to love him/her.

It would be natural to think that both these children deserve sympathy and affirmative action in some form, if only from the voice of conscience that resides deep within us.

In India, there are always more beneficiaries and claimants than funds, and orphans and destitute children have no one speaking for them.

Hence, they get lost in the push and pull over competing demands. They do not influence votes, having no parents who are voters. Orphans are not even a prominent social nuisance group. In a democracy, one of the fallouts of majority representation is that policies and funds are often around cornered by those who provide the maximum number of votes, a term we can call the votable bias. It is because of this votable bias, that there are schemes such as mid-day meal, ICDS/Anganwadi, Ujjwala - schemes that would be of importance to mother's for the children- because mothers form a large vote bank. It does not help that orphans have no political voice - there are few who speak for them, fatalism and institutional neglect making them a dispersed political entity, ineffectual in fighting for their own rights promised to them under the constitution.



There are over 2 crore orphans in India; more than the total population of Sri Lanka! This figure is from a detailed study by SOS Children's Villages. The ChildLine portal of the Government states that "UNICEF estimates that there are 25 million orphaned children in India in 2007" and, "Another study estimates that there are about 44 million destitute children and over 12 million orphan and abandoned children in India". For all we know, this figure could be much higher !!!

The heartbreaking irony is that, statistically, 70 per cent of our population is SC, ST or OBC. It goes on to mean that 70 per cent of our orphan children would obviously belong to these communities. It is a doubly cruel tragedy for orphans from the SC/ST or OBC lineage, who in another world would have had more support and more facilities from the Government, but now, due to the misfortune of not having parents, are left to fend for themselves.

".... We are guilty of many errors and many faults, but our worst crime is abandoning the children, neglecting the fountain of life. Many of the things we need can wait. The child cannot.

"Right now is the time his bones are being formed, his blood is being made, and his senses are being developed. To him we cannot answer 'Tomorrow,' his name is today." -Gabriela Mistral

The Save the orphans and empower the Vulnerable children is high thrust & pain on our agenda. In the context of Child Right, all children should receive Food, Uniform, Shelter, Water and free from all bondages, good quality of education and orphans or and vulnerable children should not left behind in any reason. The reality is that millions of the world's children are too poor to benefit from the declaration, unless there are special interventions that target their development.

Unfortunately, such children do not form a special social category in poverty

eradication intervention program, thus, their inclusion in the achievement of EFA (Education for All) appears to be a hit-or-miss phenomenon. Cognizant of the central role of poverty reduction, that is in wider global agenda and acknowledging the need to reach out to the poorest children with the objective to break the poverty cycle for them, Social Action Orphanage Organization embarked on a program of education and poverty eradication.

The Project aims at solving the problems hidden by the fact that orphans and vulnerable children are invisible; yet by the very nature of their situation, they are included among those that are classified as disadvantaged and poor in Paschim Medinipur. Children are subsumed within the poverty categories most often referred to such as households, communities, people - which means that there is a high tendency to focus on adult-related poverty while child problems are ignored, partly because children have little power and influence within a group that contains adults.

Findings reflect that children in abject problems can be recognized by rather elementary (as opposed to sophisticated) criteria. Top on the list is absence of necessities such as shelter, food, clothing and water. Equally important is the 'human condition' in terms of physical health and parental care and protection. Schooling is high on the list as a critical criterion in determining who is extremely or modestly a vulnerable and disadvantaged child.

While there seems to be national consensus among donors, the public sector and civil society that the government has made commendable progress in implementing PEAP (Poverty Eradication Action Plan) as flexibly as possible, it's evolving nature, due to the participatory and consultative reviews it undergoes regularly, does not address many of development challenges

Disadvantaged children face today. It would take lobbying and advocacy interventions to ensure that the needs and demands of children in abject poverty are met. The study on Children in Abject Poverty in West Bengal State in particular revealed that:

In health and inadequate health services remain critical challenges for children in abject poverty. The living conditions of children in almost all the Counties studied aggravates this on a positive note, over three quarters of those who fell sick sought some kind of modern treatment: very few resorted to traditional healer.

Girls are more likely to be abandoned, sex-selectively aborted or killed in stances of infanticide than are boys. **Orphan Children** are considered a burden in the local society. But we **Ambassadors** giving Hope to find own their suitable home.



Project Background:

The project came up following the living and rampant community problems such as the rising number of children that had become orphaned due parents death or and left, street children, the displaced, increased unemployment mostly among the rural women and men, low levels of agricultural development and highly addicted with local liquor, Polygamy etc. The House for Orphans will be expended and make well homely residential. The Applicant has land & Building with Asbestos Roof but now need to be making concrete Roof on it with expansions for a construction of house for Disadvantage.

Project Justifications:

Children are vulnerable to shocks and adversities and, consequently, are hardest hit by poverty. Given that childhood is the most crucial developmental period in an individual's lifetime, any damage at this stage can lead to a perpetuation of the cycles of poverty, resulting in intergenerational and/or chronic poverty and produce antisocial.

Project Goal:

Acts Ministries has a very strong goal of improving the quality of life of the vulnerable children through provision of Food, Shelter education and psychosocial support programs.

Reporting & Evaluation:

Ambassadors Service Society will keep all records of the project on a monthly basis. The reports will be kept in accordance with the work plan that will be prepared at the beginning of the project. The Project Superintendent will ascertain that the work plan is strictly followed and that delays in implementation are totally avoided. The monthly reports will assist the Project Staff in preparing the semi-annual reports. - Adherence to the proposed activities and their subsequent budget line items.
- Efficiency and effectiveness of implementation of the activities.
- Cost effective measures put in place by the implementer.

The evaluation should also focus on: -

- The relevance of the project to the beneficiaries.
- The impact of the project to the beneficiaries.
- The extent to which the project has made a positive impact to the lives of the beneficiaries and their families/dependants.
- The Superintendent will document all lessons learnt from this project. This will not only show how successful (or otherwise) the project has been but will also guide if there are intentions of expanding the project or initiating a similar project in future. 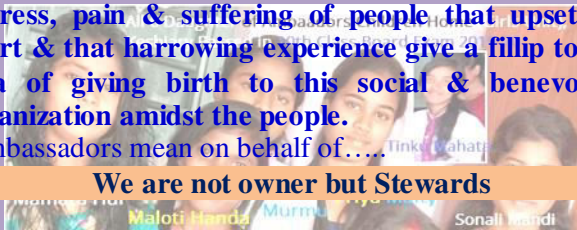
