

# General Provisions

The charity program of the Charity Foundation “Dari Edu” has been developed in accordance with the requirements and provisions of the Constitution of the Russian Federation, the Civil Code of the Russian Federation, the Federal Laws “On Non-Commercial Organizations”, “On Charitable Activities and Charitable Organizations” (in particular, on the basis of Article 17 of the Federal Law of August 11, 1995 N 135-FZ (ed. dated 05.05.2014) "On charitable activities and charitable organizations"), other legislative regulatory legal acts of the Russian Federation, the Charter of the Charity Foundation “Dari Edu”

The Charitable Program (hereinafter referred to as the Program) is a set of activities aimed at solving problems that correspond to the statutory goals of the Charity Foundation “Dari Edu” (hereinafter referred to as the Fund).

The program is indefinite. The Foundation reserves the right to make changes to the Program as charitable activities expand.

# Mission and purpose of the Program

## Mission of the Program

**Promoting the format of affordable and daily charity.**

**Provision of social support and charitable assistance to socially unprotected categories of the population/citizens in Russia by providing food donated for this purpose to the Foundation by individuals and legal entities and brought to the beneficiaries (individuals) through a partner network of non-profit organizations and volunteers.**

**As part of the implementation of the Program, the Foundation financially provides for the transportation of donations, as well as the purchase of necessary products and consumables for the implementation of individual charitable projects, except when these costs are covered by the non-profit organization itself or the charitable company.**







# Purpose of the Program

**The purpose of the Program is to accumulate property (cash, food and non-food property donations, other types of property) received through voluntary donations from legal entities and individuals, as well as attracted by other activities not prohibited by law, and the use of this property for charitable activities aimed at:**

- social support and protection of citizens, including the improvement of the material situation of socially unprotected categories of the population; it means, among other things, to save the expenses of citizens, which takes place when receiving a charitable donation in the form of food and non-food consumer goods.**
- promotion of activities in the field of prevention and protection of the health of citizens, as well as promotion of a healthy lifestyle, improvement of the moral and psychological state of citizens; including by providing additional nutrition.**
- promotion of volunteering.**

**Provision of charitable assistance, including financial (in cash) or in kind (food, other consumer goods) to non-profit organizations and (or) individuals, can be carried out by providing donations and grants, paying scholarships, awarding prizes, provision of consultations and other means not prohibited by the current legislation.**

# **Principles of the Program**

## **Legality**

**In the process of implementing the Program, the Foundation strictly observes the legislation of the Russian Federation, generally recognized principles, and norms of international law.**

## **Openness**

**The program is open for participants to join. The number of Program participants is not limited.**

## **Transparency**

**The Fund regularly publishes reports on the use of donations on its website, annually posts a consolidated report on the implementation of the Program on the website.**

### **Relevance and effectiveness**

**When providing charitable assistance, the Fund is guided by the principle of priority support for the neediest categories of the population. A person who, due to improved life circumstances, has lost the status of a needy person is not entitled to remain a recipient of the Fund's assistance.**

# Geography, terms, and stages of the Program implementation

## Geography of the Program

**The program is being implemented on the territory of the Russian Federation.**

### **Terms of the Program implementation**

**The term of the Program implementation is defined as 30 years. The implementation of the Program does not depend on the planned quantitative indicators of the Program; for any available quantitative indicators, the Program is considered to be implemented and after the expiration of the implementation period - implemented.**

**The duration of the Program may be changed in the manner provided in Section 12.**





# Sources of funding for the Program

**The Program is financed by:**

- **charitable donations, including targeted ones, provided by individuals and legal entities in cash and (or) in kind.**
- **other sources not prohibited by the legislation of the Russian Federation.**



# Planned results of the Program implementation

- **Promoting the format of affordable and everyday charity.**
- **Improving the financial situation of socially unprotected categories of the population; at the same time, the improvement of the financial situation is understood, among other things, to save the costs of beneficiaries-individuals.**
- **Improving the quality of life of citizens by providing food and other consumer goods.**
- **Reduction of social tension in society.**
- **Putting into practice new mechanisms for collecting and distributing property donations: creating a system of interaction between business and non-profit organizations, which makes it possible to promptly distribute large volumes of products among beneficiaries-individuals throughout Russia.**
- **Development of corporate social responsibility of companies, in particular, corporate "volunteering" (activities as volunteers) of employees.**
- **Development of volunteering in Russia.**



# Participants of the Program

**Program participants are citizens and legal entities engaged in charitable and other activities in order to implement this Program, as well as citizens and legal entities, for who charitable activities are carried out in order to implement this Program.**

**Program participants are philanthropists, volunteers, beneficiaries.**

**The Foundation acts as both a philanthropist and a beneficiary within the framework of the Program. The Fund is the main organizer, coordinator, and executor of the Program, carrying out general management of the Program implementation and ensuring the interaction of the Program participants and its implementation.**

- **monitor and control the implementation of the Program.**
- **performs other functions in accordance with these Regulations, internal documents of the Fund.**

## **The Foundation has the right to:**

- **carry out regulation on all issues related to the implementation of the Program.**
- **send their representatives to participate in any activities of the Program.**
- **ask all participants of the Program for the necessary information.**
