# Rain and LBOD Water from Nawabshah and Sanghar in Mirpurkhas

This report of losses and damages has been prepared by the team of Advocacy, Research, Training and Services (ARTS) Foundation. Mirpurkhas has adversely affected by series of rain as started in the mid of July continued for the last week of August 2022 and then badly mad worse conditions as water arrived from Nawabshah and Sanghar through LBOD thus the heavy water made breaches in banks of LBOD which brought heavy flooding in whole Mirpurkhas district.



The objective of this strip is to collect, compile and present losses and damages as made in district Mirpurkhas due to rain 2022 and water from Nawabshah and Sanghar through LBOD for the persuasion decision makers, provincial government, district administration, NDMA, PDMA, UN Agencies, Humanitarian Organizations, Philanthropists and Donor Community/INGOs/LNGOs for timely response, early recovery and rehabilitation by identifying the needs of the most vulnerable communities affected through Rain 2022 and Water from Nawabshah and Sanghar through LBOD which causing heavy damages and losses to people of district Mirpurkhas.



According to first rapid assessment by district administration, the losses as of August 19, 2022 has reached as given in the below table. But heavy rain has hit again on 23 and 24 August 2022 also, the assessment is in process to gauge volume of losses and damages.






Mirpurkhas lies in the southern part of the Sindh province and shares a Western border with Hyderabad to the North is Sanghar and Umerkot in the East with Tharparkar and South with Badin and Tharparkar. According to 2017 census, district has a population of 1,505,876 with 286,547 households its spread over 2925 square kilometers. The district is comprised of 7 Talukas i.e. Mirpurkhas, Shuja Abad, Dighri, Sindhri, Hussain Bux Mari, Jhudo and Kot Ghulam Muhammad.

## Immediate Needs and Actions Needed

Keeping in view the severity of the rain 2022 and waters from Nawabshah and Sanghar through LBOD which causing flooding and displacement of people in the district, the following immediate needs and actions are needed very prompt;

- Government of Pakistan/Government of Sindh must call for flash appeal to UN Agencies, Donor Community, INGOs/LNGOs for humanitarian assistance and operations through LNGOs
- Chief Minister Sindh must visit district Mirpurkhas on immediate basis to announce a relief, restoration, rehabilitation package for vulnerable communities and district infrastructures
- Immediate arrangement and provision of Tents, Food, Safe Drinking Water, Mosquito Nets, WASH/Sanitary Kits, Temporary Toilets through NDMA/PDMA, UN Agencies, Donor Community, INGOs/LNGOs
- Immediate availability of Mobile Medical Camps/Vaccination Services
- Immediate provision of Dewatering Pumps and Machines by NDMA/PDMA to District Administration
- Immediate and special arrangements for pregnant women, lactating mothers, persons with disabilities, old age people, women headed households and transgender community

With reference to the subject cited above, it is submitted that recent torrential monsoon rains have wrecked havoc in many parts of the District with more than 200 mm rainfall recorded in most parts of district Mirpurkhas in the last 24 hours alone. Thousands of people from different localities have been affected and heavy losses have incurred to the life, properties, infrastructure, and crops due to unprecedented rainfall. The District Administration has established relief camps throughout district to facilitate the affected populations. It is estimated that more than 250,000 people have been directly affected by these rains.

It is requested that in view of casualties and huge losses to properties, crops, livestock and infrastructure by recent torrential rains, District Mirpurkhas be declared as "Calamity-hit District"
