Dear Friends at Delta Airlines,

One fateful night, the blanket 11 year old Wushuang was sleeping in caught fire from a nearby space heater. Her entire house was quickly engulfed in flames!

Wushang was critically burned over 75% of her body. Luckily her father escaped but sadly, her mother perished in the fire.

She lay near death on a respirator in a China hospital for weeks. Finally she received her passport and visa to travel to the U.S. for extensive treatment donated by the Shriners and was escorted by volunteers with the **Airline Ambassadors Medical Escort Program**



The surgery she received saved her life, and today...25 surgeries later, Wushang has graduated from Marion University in Indianapolis with a BS in biology and a BS in Biomedical Engineering and is now employed full time with Ely Lilly. You can read her entire story here.

Over the years the Airline Ambassadors Medical Escort program has brought over 3,000 children to the United States for life changing and life saving medical procedures not available in their home countries and completely unaffordable by their families.

This program, directed by long time volunteer, Margaret Whitehead is a unique and rewarding way for airline personnel to volunteer as a guardian for a frightened child on the most important journey of his/her life.

Today, I am contacting you because we need Delta Airlines help to continue this critically important program.

Recently **Delta flight attendant, Cheryl Robinson,** was honored with the Chairman's Award. Cheryl has served as an Airline Ambassadors Medical Escort, and can attest the impact this program has on the children, the volunteer employees and the public at large. She is such an inspiration and has also led humanitarian missions to the Philippines and South Africa for



many years. Cheryl would be an excellent spokesperson to highlight the impact that Delta could make if they adopt this program. The good will generated by the program and positive social media posts will help tell the world the good Delta is doing for children in need.

Delta could add this program to the SkyMiles program to provide resources for the children traveling for donated medical care.
