8) Establish judicial and extrajudicial proxies; 9) Celebrate the contracts or agreements authorized by the Board of Directors, on the defined dates and/or with their execution deadlines; 10) Provide the positions that the foundation requires for its proper functioning and assign them the corresponding compensation; 11) Present to the Board of Directors the projects for the creation and modification of operational units, educational and sports programs; 12) Decree the rules that it deems appropriate for the normal administrative functioning of the foundation; 13) Direct the due and timely accounting of the foundation's accounts; 14) The others indicated by the Board of Directors; and 15) Attend the Board of Directors and render all collaboration that is pertinent to the normal functioning of the foundation and its programs.

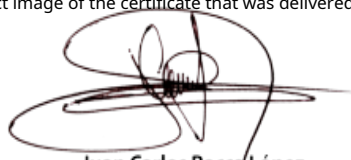
